That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and the total loss suffered is estimated to be about Rs.11,60,000/- (Rupees Eleven Lakhs Sixty Thousand) only.

In the given circumstances, I humbly pray you to kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
