With reference to the above cited subject, I, the undersigned, Chief of Dopkon Village, have the honour to report to you as follows:


- 1. That, the villagers of Dopkon Village belong to various tribes recognized as Scheduled Tribes under the Constitution of India.
- 2. That, at about 8.00 AM, on the 8<sup>th</sup> of May, 2023, a huge contingent of armed radical Meitei/ Meeteis, along with the Manipur Police Commando and the Indian Reserve Battalion (IRB) attacked our village and in the process, they have vandalized, destroyed and burnt the following properties:
