Subject: - First Information Report on the crime of vandalism and arson attack on the **Public Properties at Dopkon Village, P.O., P.S. & District- Churachandpur, Manipur** on the 8th of May, 2023.

Dear Sir,

With reference to the above cited subject, I, the undersigned, Chief of Dopkon Village, have the honour to report to you as follows:

1. That, the villagers of Dopkon Village belong to various tribes recognized as Scheduled Tribes under the Constitution of India.
2. That, at about 8.00 AM, on the 8th of May, 2023, a huge contingent of armed radical Meitei/ Meeteis, along with the Manipur Police Commando and the Indian Reserve Battalion (IRB) attacked our village and in the process, they have vandalized, destroyed and burnt the following properties:

1.	2 Nos. Bore wells	Rs. 5,70,000.00
2.	Anganwadi Centre building and Misc. items	Rs. 30,00,000.00
3.	CGI Pipe (1.5 Inch) 500 Nos. @ Rs 3,500	Rs. 17,50,000.00
4.	Water tank (Reservoir)	Rs. 9,00,000.00
Total		Rs. 62,20,000.00

3. That, the total loss caused by the above mentioned criminal activities may be estimated to be approximately **Rs. 62,20,000/- (Rupees Sixty Two Lakhs Twenty Thousand) only**.
4. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
