

Subject: - First Information Report on the crime of vandalism and arson attack on the **Public Properties at Khuangmun Village, P.O., P.S. & District- Churachandpur, Manipur** on the 8th of May, 2023.

Dear Sir,

With reference to the above cited subject, I, the undersigned, Chief of Khuangmun Village, have the honour to report to you as follows:

1. That, the villagers of Khuangmun Village belong to various tribes recognized as Scheduled Tribes under the Constitution of India.
2. That, at about 10.00 AM, on the 8th of May, 2023, a huge contingent of armed radical Meitei/ Meeteis, along with the Manipur Police Commando and the Indian Reserve Battalion (IRB) attacked our village and in the process, they have vandalized, destroyed and burnt the following properties:



2.	Tullu (water pumps)	Rs. 55,000.00
3.	CGI Pipe (1.5 Inch) 170 Nos. @ Rs 3,500	Rs. 5,95,000.00
4.	CGI Pipe (2 Inch) 35 Nos. @ Rs 6,000	Rs. 2,10,000.00
5.	Water tank (Reservior)	Rs. 9,00,000.00
Total		Rs. 23,30,000.00

3. That, the total loss caused by the above mentioned criminal activities may be estimated to be approximately **Rs. 23,30,000/- (Rupees Twenty Three Lakhs Thirty Thousand) only.**
4. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
