Whereby, I was thrashed and beaten black and blue. Later, I was set freed from their custody, meanwhile my vehicle Mahindra Jeeto bearing Regd. No. MN06L 8745, Chassis No. MA1KD2UBEG3D59098, Eng. No. UBG3D34579, mfg. Mahindra and Mahindra Ltd, Color- Blue was torched and gutted down.

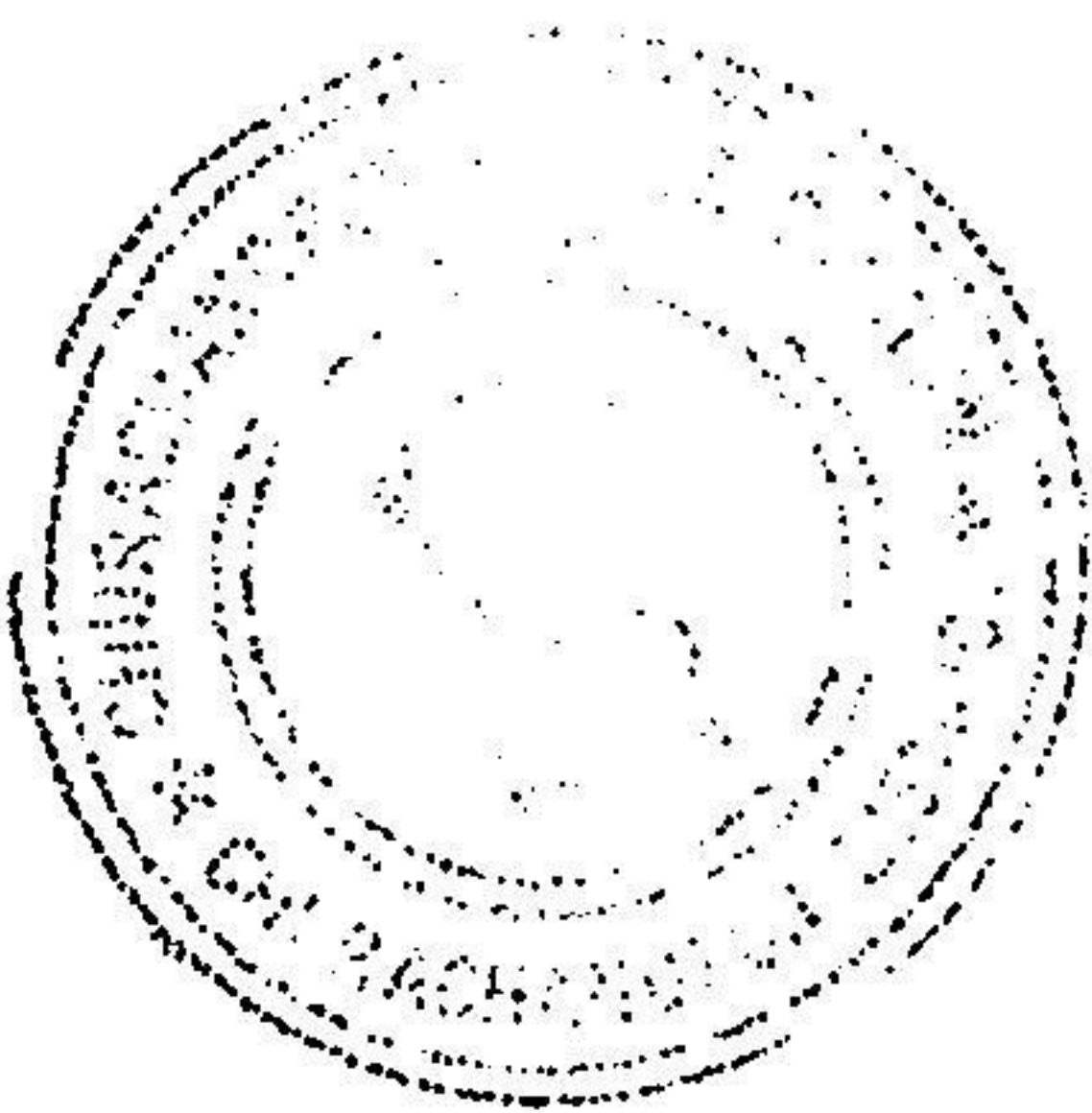
