On 13th August, 2023 at 8:30 am, received a reliable information that a joint team of 133 CRPF, 10 BSF, 16 Kumaon Regiment and CCP Police manning Joint Forces Check Post at Torbung Bangla had intercepted one white color Tata Winger Ambulance bearing registration No. MN02C 0188 on 12th August, 2023 at 7:00 pm and recovered one AK-47 rifle with Chinese markings Butt No. 78 with 24 rounds and one SLR B/Regd No. 001561 with 17 rounds from the possession of Mr. Lenminlal Gangte s/o James Laorobul and Mr. Simon of Tuibuong Khopi. However, a large mob of womenfolk numbering around 600-700 led by ITLF and Kuki Women Union intervened and a tussle ensued between the womenfolk and the security personnel. The womenfolk forcibly took away the two individuals from the custody of security personnel. The arms and ammns are kept in the custody of Joint forces at Torbung Bangla.

Hence, a Suo motu case under FIR NO. 1291(08)CCP-PS u/s 186/225/34 IPC & 25(1-C) Arms Act has been registered against the two individual and womenfolk of ITLF and KWU for investigation.
