- 1. That I Neikim Haokip aged about 60 years W/o V.T Jangkholun Haokip Belonging to the AnyKuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of Ukhatampak Village Churachandpur.
- 2. That at about 5 am on the 5<sup>th</sup> Aug 2023, a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun numbering about 2000 attacked our locality and in the process, they have looted, Vandalised and burnt down my house as well our Granary and some of our Original Documents.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be Rs. 5151000 (Rupees Fifty one Lakhs Fifty one Thousand ) only
- 4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and now currently taking refuge at Molnom Village Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Molnom Village And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
