- 1. That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India. And I am a permanent resident of S.Kotlian Village, P.O., P.S. & District- Churachndpur, Manipur.
- That, on the 3rd of May, 2023, at about 6:00PM, a huge contingent of armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked, looted, vandalized and torched my Shop located at Torbung Village. P.O., P.S. & District- Churachndpur, Manapur, leaving behind my Shop Registration Documents and so on.
- 3. That, it may be reported here that the miscreants were shouting slogans like"KANGLEIPAK YAIPHARE"; "KUST HATLO"; "HAO HATLO"; etc. while they were
 carrying out their criminal activities. It seems to me that all these has taken place at the
 instance of the Manipur State Government as the perpetrators openly claimed and
 shouted that nobody would stop them, even the police because everyone, including top
 officials of the Manipur Government are patronizing them and that that no harm could be
 done to them.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health

and I am settled at a relief center at Chiengkon Village, which is set up/ organized by the Young Mizo Association (YMA) And, thus I am filing the report lately today.

In the given circumstances, I humbly pray you to kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
