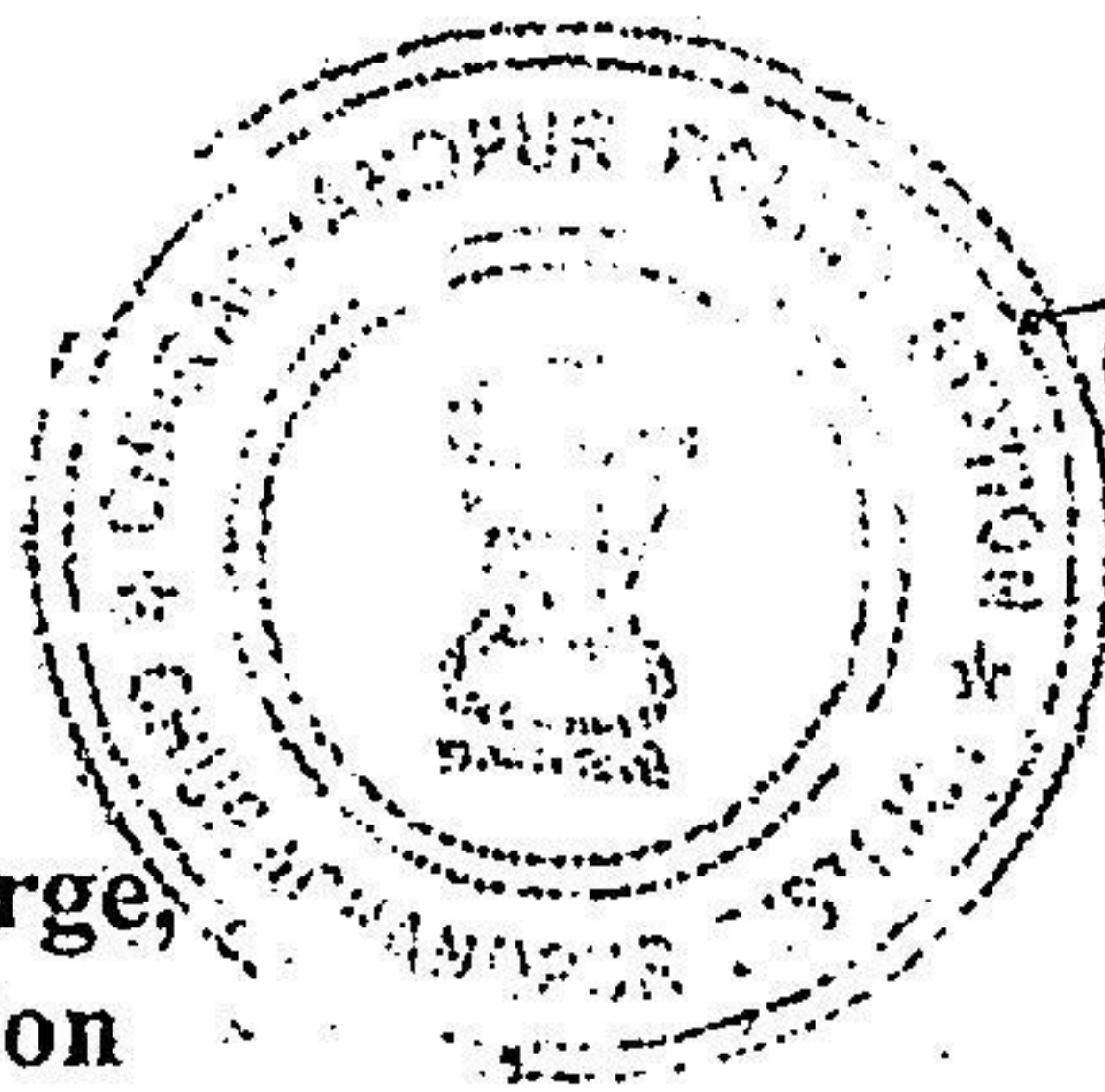

Subject: - Complaint/ Report on crimes of looting, vandalism and arson-attack of Residential house and the properties / discrimination of Scheduled Tribes. Officer-in-Charge
Churachandpur Police Station
Manipur

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Thadou - Kuki Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in Manipur, I and my family left our permanent resident located at Ukhatampak Village, Kangvai Sub-Div., P.O., P.S. & District - Churachandpur, on the 3 of May, 2023 at around 5 AM/PM, where we made an escape to save our lives, took refuge at relatives house at Lamka Town. And, it has come to my knowledge that my Residential house along with the deserted properties was looted, vandalised and torched by a Group of radical Meitei/ Meiteis suspected to be members of *Arambai Tengol* and *Meitei Leepun* headed by State Police Commando on the 5th of August, 2023 at around 4:30 AM.

That, while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, above-mentioned properties are estimated to be about Rs. 14,15,000/- only.
