With due respect I,Sehlun Singsit age about 59 years S/O (L) Haokholam a residence of Tuipi Veng, Headquarter, Churachandpur P.O.&P.S. Churachandpur would like to bring forth to your kind knowledge that I am a serving Pastor of Evangelical Churches Association (E.C.A) with its headquarter at Chiengkon, Churachandpur presently posted at Ningthi Pastor Area, Henglep Sub-Division, P.S. Churachandpur, District Churachandpur and that I along with my family fled towards Lamka, Churachandpur for our own safety leaving behind our properties on the 3rd May 2023 as the ethnic clash have create such an atmosphere which became impossible for living.

That, my Pastor Quarters located at Ukha Tampak Village B.P.O. Phuaisanbung P.S. Churachandpur with all our belongings was looted and burn to ashes on the 5th day of August 2023 at around 5:00 am intentionally knowing to be part religious property as it was located within the Church campus by valley base Meitei miscreant with the help of State Police Commando suspected to be from Bishnupur, Manipur, thereby causing a loss to a value of about Rs.4,500,000/-(Rupees Forty Five Lakhs Only) which include of Semi-Pucca Building, house hold items, furniture, kitchen wear etc.

Therefore, I, would like to request your kind office to initiate necessary action at the earliest for which I will remain thankful to you.
