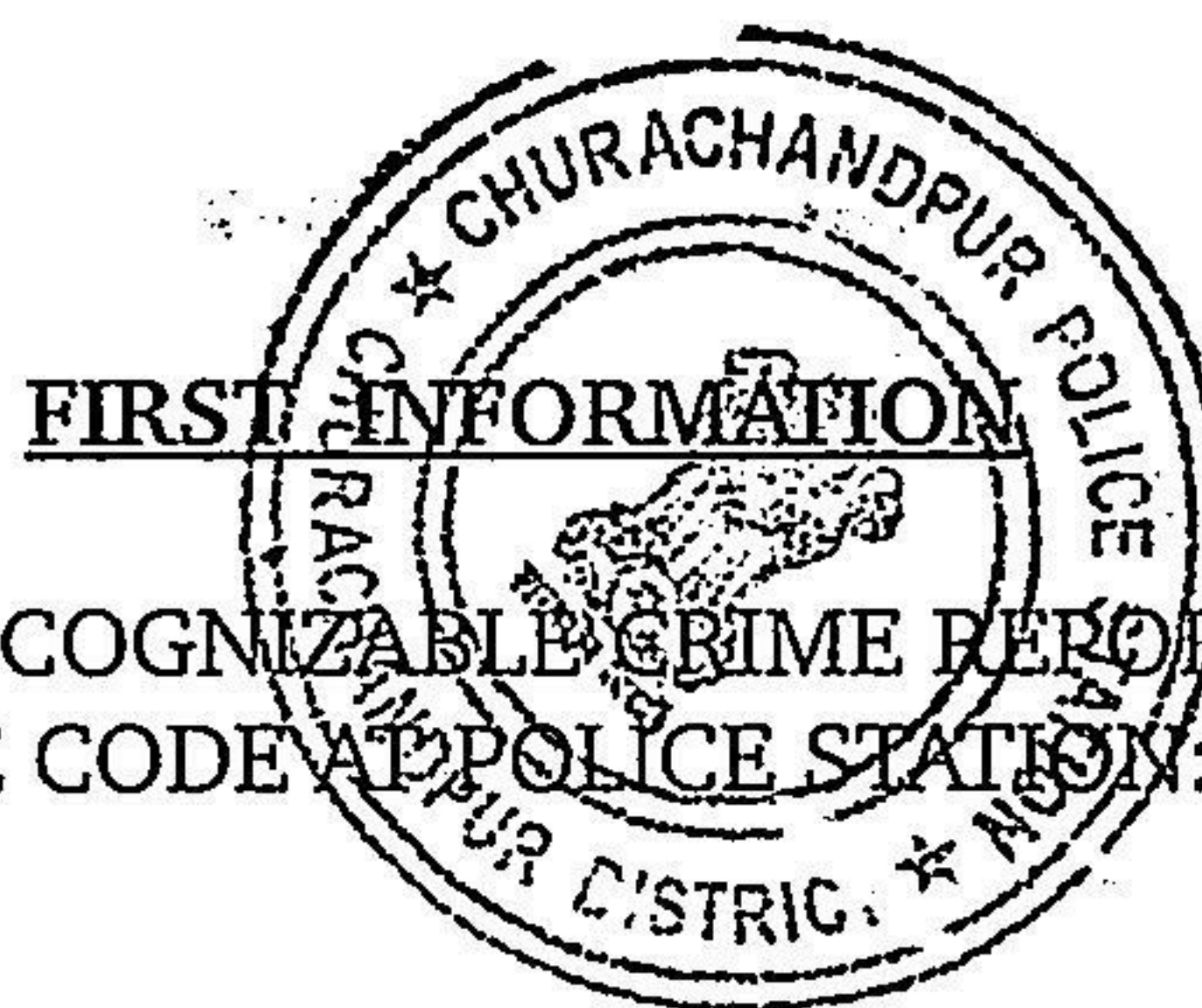

I would like to report that
on 18th May, 2023 we came to know
that the PHED Department pipes which
were kept and stock at Aungnak Road,
near petrol pump, New Lamka were found
missing and highly suspected to be
stolen away by unknown persons. No. of
GI pipes missing: (i) GI pipes 100mm -
80 pcs. (ii) GI pipes 20 mm - 130 pcs.

Again, on 15th May to 31st July, 2023
approximately 15,000 pcs of Department
pipes which were stock at ZMB (Kawnpui)
Brickfield were stolen away by unknown
persons and could not be recovered back
till date.
