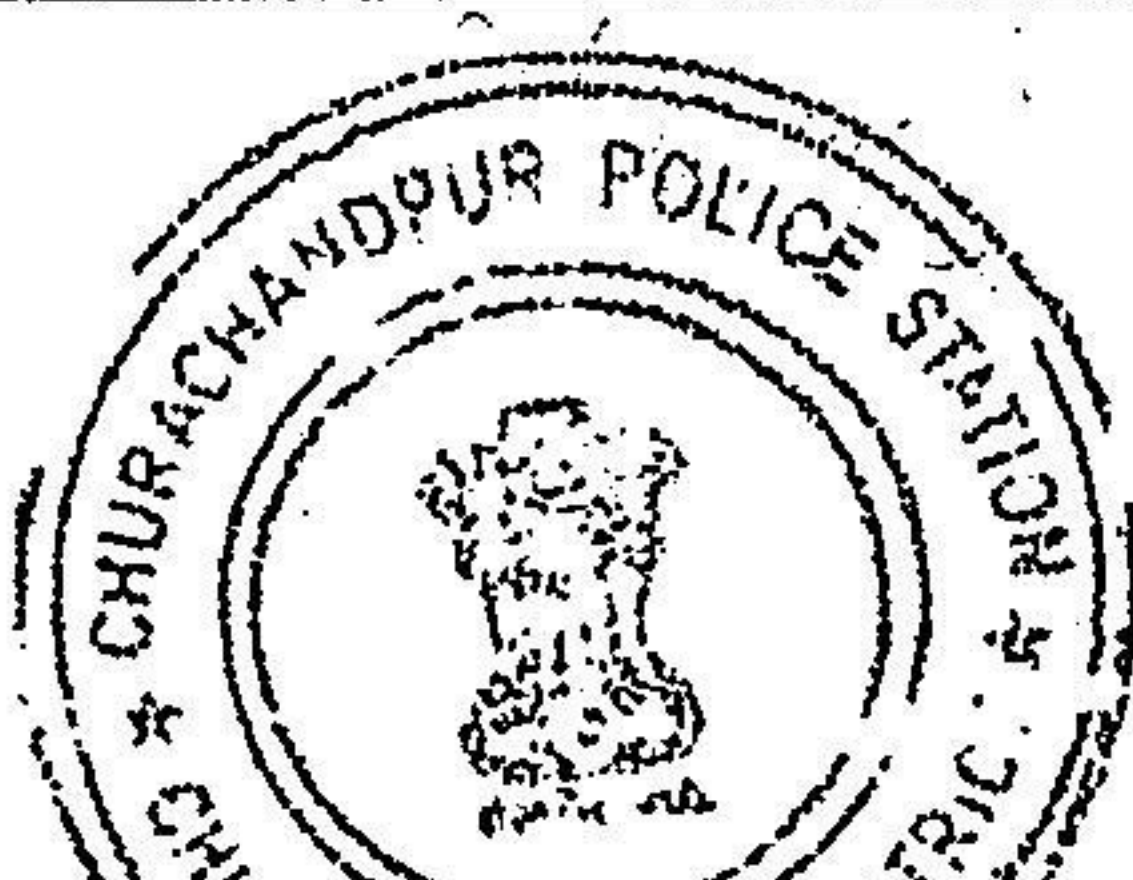

Sir,

With due respect, I would like to state that as per SP, CCPur order No. B-12/13(L&O)/SP-CCP/2018/2418 dated 04/06/2023 and CO, 1st IRB authorisation for movement dated 05/08/2023, I, the undersigned, alongwith my team from BN. HQ., 1st IRB was deployed as Reinforcement Team to assist the Gothol post whilst heavy exchange of fire with armed miscreants suspected to be valley based UGs at Gothol-Pholjang Village and its adjoining area. We stayed in the post from 05/08/2023 till 07/08/2023.

On 05/08/2023 we arrived at the place of incident at around 10:00 AM. During that time, 1st IRB Gothol Post was receiving intermittent firing from the armed miscreants suspected to be Valley based UGs along the eastern border of the village. The firing soon turned into heavy continuous firing wherein the armed miscreants started using explosives and fired MORTAR Shells towards 1st IRB Post and also at BSF and District police personnel who were also on duty at Gothol village. In retaliation to the heavy firing and MORTAR Shells shot towards the village and 1st IRB Post and in the attempt to stop the advance of the armed miscreants and to subside the situation, the following ammunitions and explosives were fired by duty personnel towards the miscreants from 10:00 AM to 4:00 PM of 05/08/2023:
