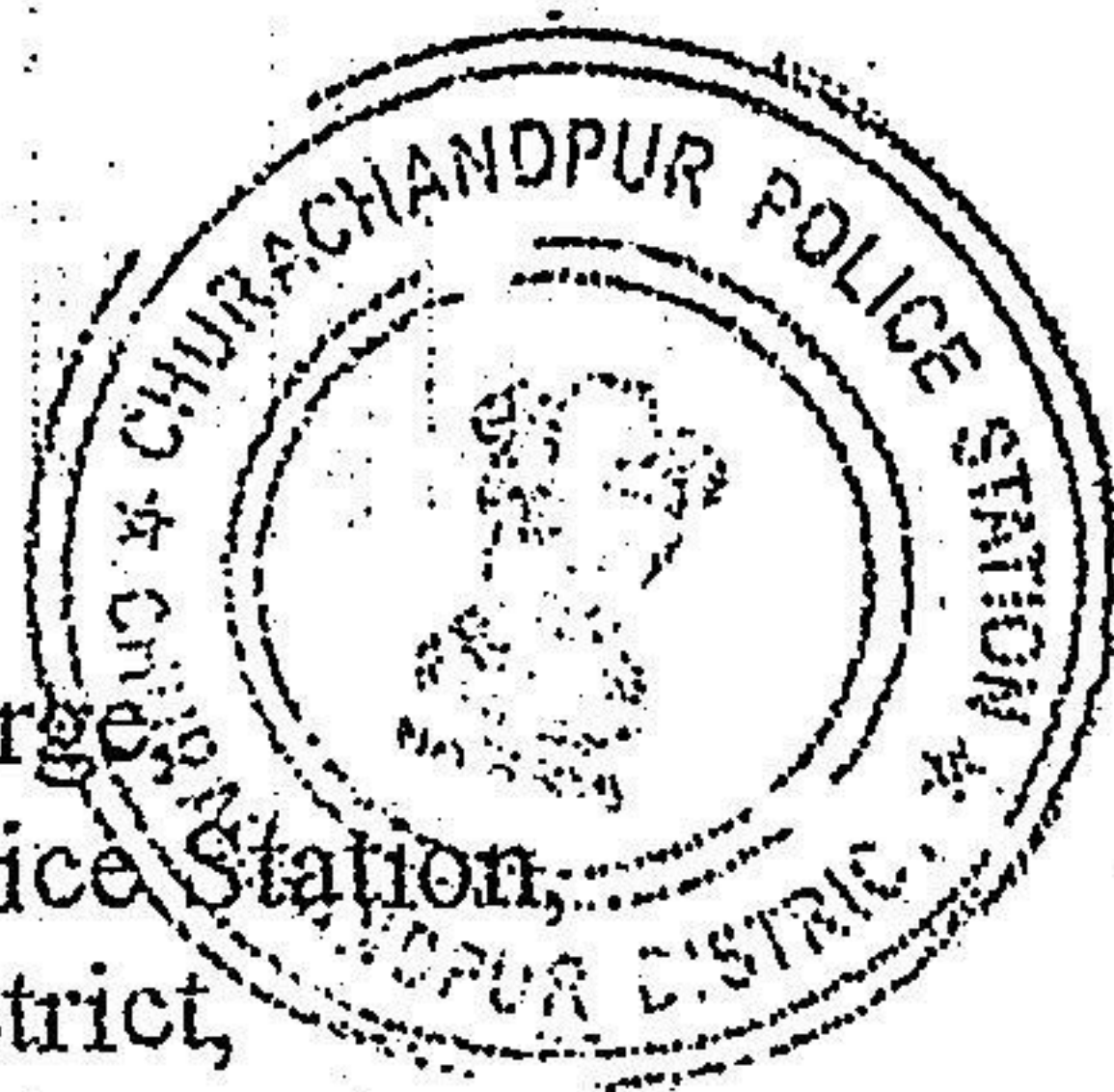

Subject:- First Information Report on the crime of vandalism and arson attack on the Public Properties at Ukha Tampak Village, P.O., P.S. & District- Churachandpur, Manipur on the 5th of August, 2023.

Dear Sir,

With reference to the above cited subject, I, the undersigned, Chief of Ukha Tampak Village, have the honour to report to you as follows:

1. That, the villagers of Ukha Tampak Village belong to various tribes recognized as Scheduled Tribes under the Constitution of India.
2. That, at about 4:30 AM, on the 5th August, 2023, a huge contingent of armed radical Meitei/ Meeteis, suspected to be members of the Arambai Tenggol and the Meitei Leepun, led by the Manipur Police Commando attacked our village and in the process, they have vandalized, destroyed and burnt the following properties:

1.	Anganwadi Centre building and Misc. items	Rs. 400000
2.	Community Hall, furniture and Misc. items	Rs. 2000000
3.	ASHA Centre building & Misc. items	Rs. 300000
4.	BBNL Wifi at Common Service Centre	Rs. 400000
5.	Jal Jeevan Mission	Rs. 4000000
Total		Rs. 7100000

3. That, the total loss caused by the above mentioned criminal activities may be estimated to be approximately Rs. 7100000 (Rupees Seventy one lakhs) only.
4. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
