

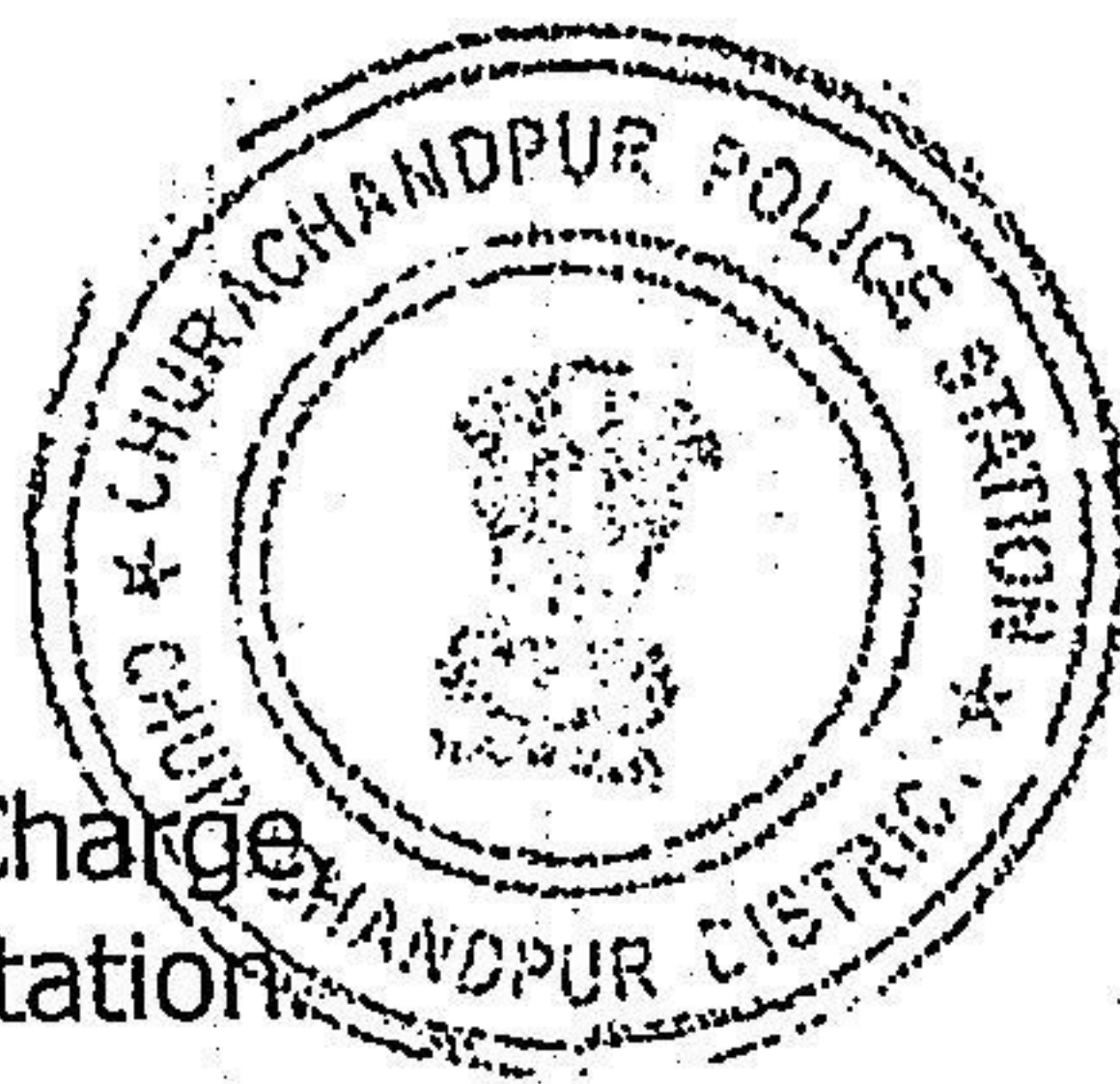

I have the honour to report that on 3rd May, 2023 at about 06.00 pm my Hero Maestro Edge 125 BS6 FI D, Yellow and Black in colour bearing Regn. No. MN01AN having Engine No. JF17EANG11343 & Chassis No. MBLJFW410NGL01259 has been found stolen/burnt down by unknown Kuki miscreants accompanied by its supporters. My Hero Maestro Edge 125 BS6 FI D was being kept parked under lock and key in the garage of my neighbour namely Moirangthem Kuber Singh S/o M. Ibo Singh of Khumujamba Meitei Leikai, Churachandpur. The cost of the stolen vehicle is Rs. 1,15,000/- (approx.). I could not report in time due to present violence.
