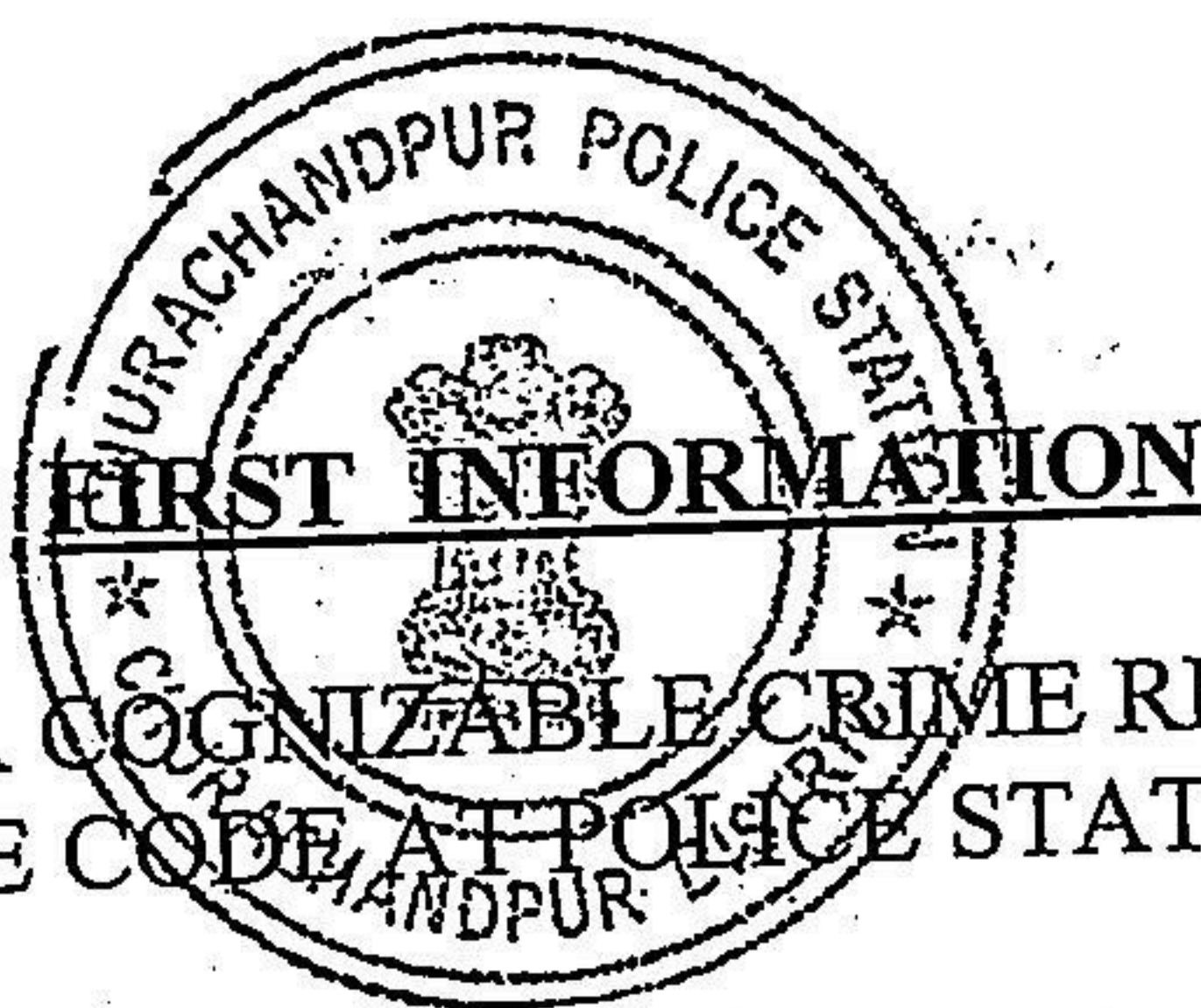

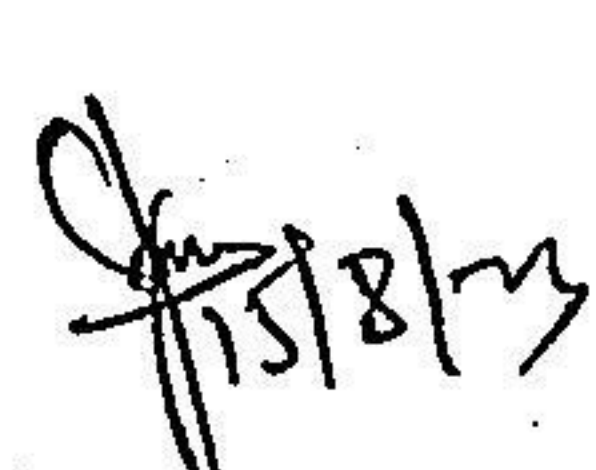

I have the honour to state that on 03/05/2023 at around 08:00 pm a group of unknown people numbering about 100/150 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched our Lath Machine 6 feet, Lath Machine 8 feet, Lath Machine 10 feet, Hydraulic Machine 150 tone, Generator 25 KB, Drill Machine Heavy, Welding Machine etc. which were also kept inside the IR Engineering Work Shop located at Churachandpur Family Lane along with the two Scooters. The total cost of the lost value of the above items could be around 1 crores. They have looted all said items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).

My particulars are stated above and I was born and brought up at the above
mention address. I have three siblings and I am the second issued of my
parents. My parents namely Naorem Kala Singh and Naorem (O) Memcha Devi are
cultivators as well as shop-keeper at my locality and they both are old-aged
persons. I married with Naorem (O) Rangela Devi, 40yrs and we are blessed with
2 sons and 1 daughter. My eldest daughter is reading at class 8, eldest son is
in class-3 and youngest son is reading in class-1. They all are reading at
St Mary's School, Churachandpur and my wife is a house-wife, she looks
after my children as I am busy with my business. ^{most of the time,}

I have a workshop named IR Engineering Workshop situated at Churachandpur
Family Lane. The distance between my residential house located at Khumajamba
Meitei Leikai to and my workshop is about 1 kilometre.

On 3/5/2023, a rally was organised by All Tribal Students Union Manipur
(ATSUM), after the peace rally, the tension between Kuki community and
Meitei ~~has~~ enhanced at Churachandpur area increased.

On the same day at around 8:00pm, a group of unknown people to numbering
about 100/150 suspected to be ATSUM stormed into our locality with arms
and other incriminating weapons. Firstly, they vandalized meitei's houses
and looted and burnt down all the houses of meitei peoples.

On 5/5/2023, some unknown persons suspected to be Kuki militants stormed
into my IR workshop named 'IR Engineering Workshop' located at Churachand-
pur Family Lane. They vandalized all my machinery items of my workshop
and then they put ~~it~~ out all ^{all the} machinery items of my workshop and
placed it on the road and they then they ~~has~~ have torched it.
They have torched my Lath Machine 6 feet, Lath Machine 8 feet, Lath Machine 10
feet, Hydraulic Machine 150 ton tone, Generator 25 KB, Drill Machine Heavy,
Welding Machine and other many two wheelers vehicles, other sophisticated
electronic items. ~~The have lost~~ The approximate estimated cost of the
above mentioned items may be ~~6000000~~ ^{one crore}
