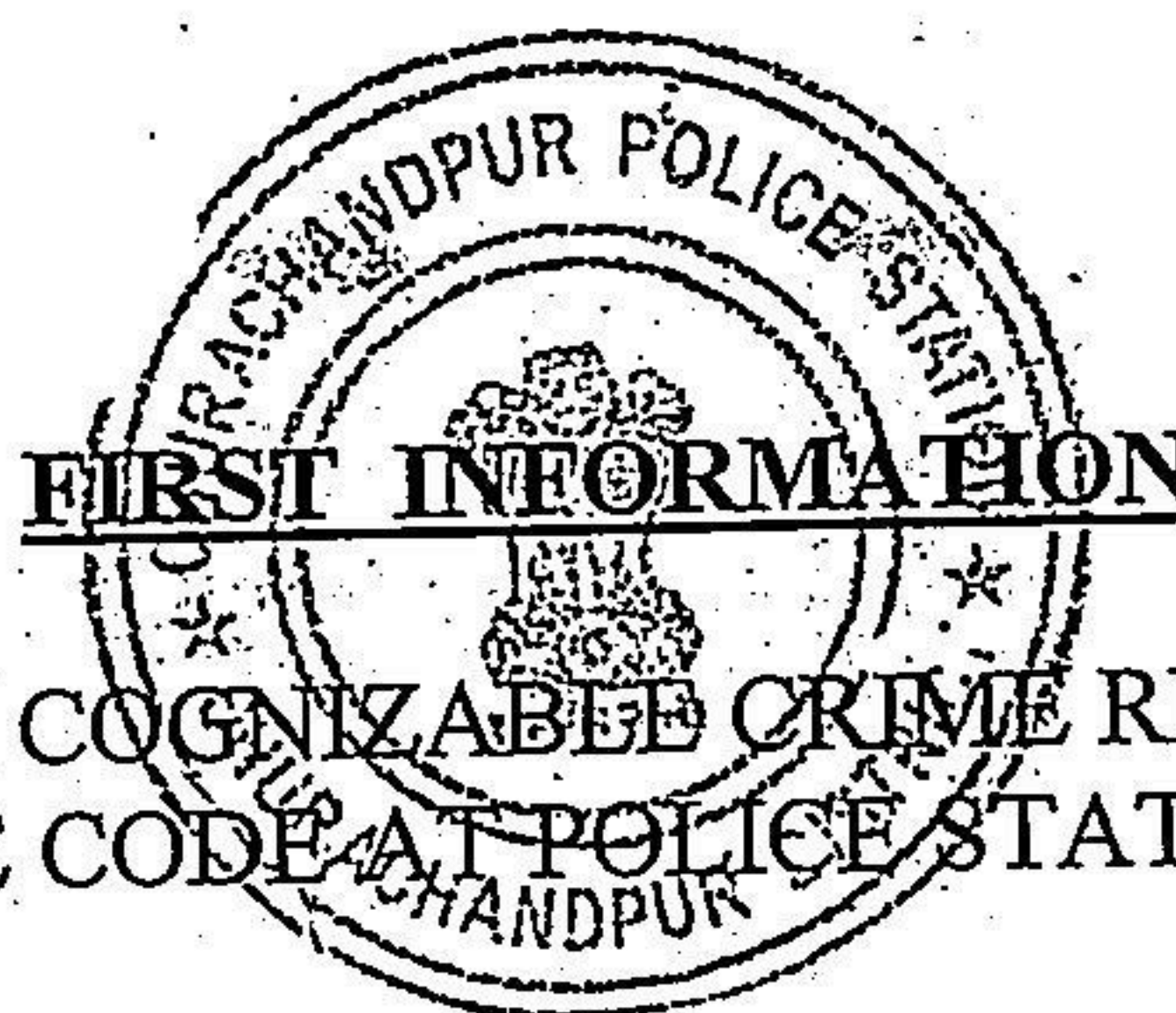

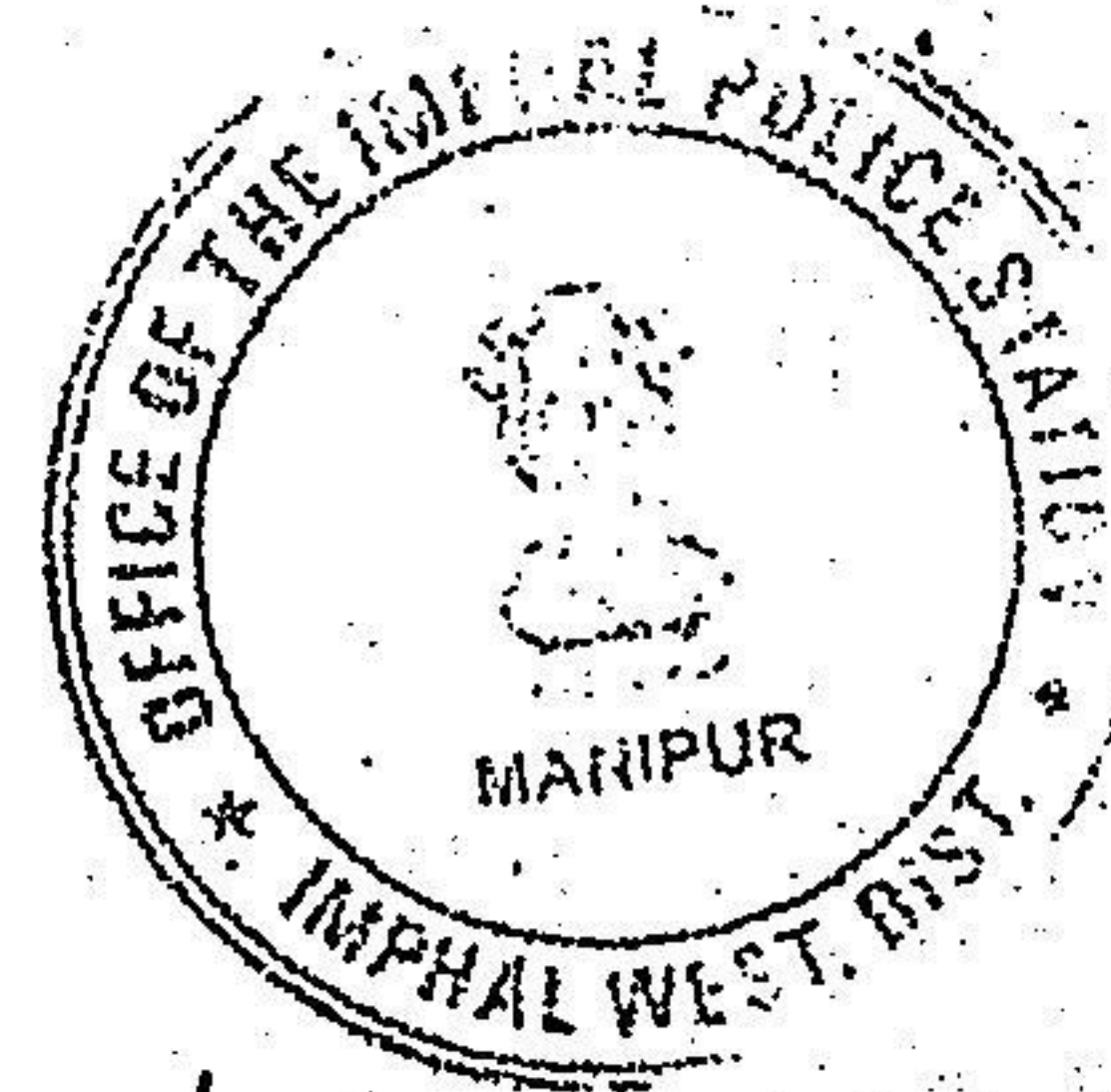

I have the honour to state that on 4/5/2023 at around 11:00 A.M a group of unknown people numbering about 400, suspected to be members of ALL TRIBAL STUDENT UNION MANIPUR (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my house and my properties with one Honda Activa (Scooty). The total cost of the lost value would be around 80 lakhs. They have looted all my household items and valuable assets.

It is therefore requested kindly to take up necessary legal action.
