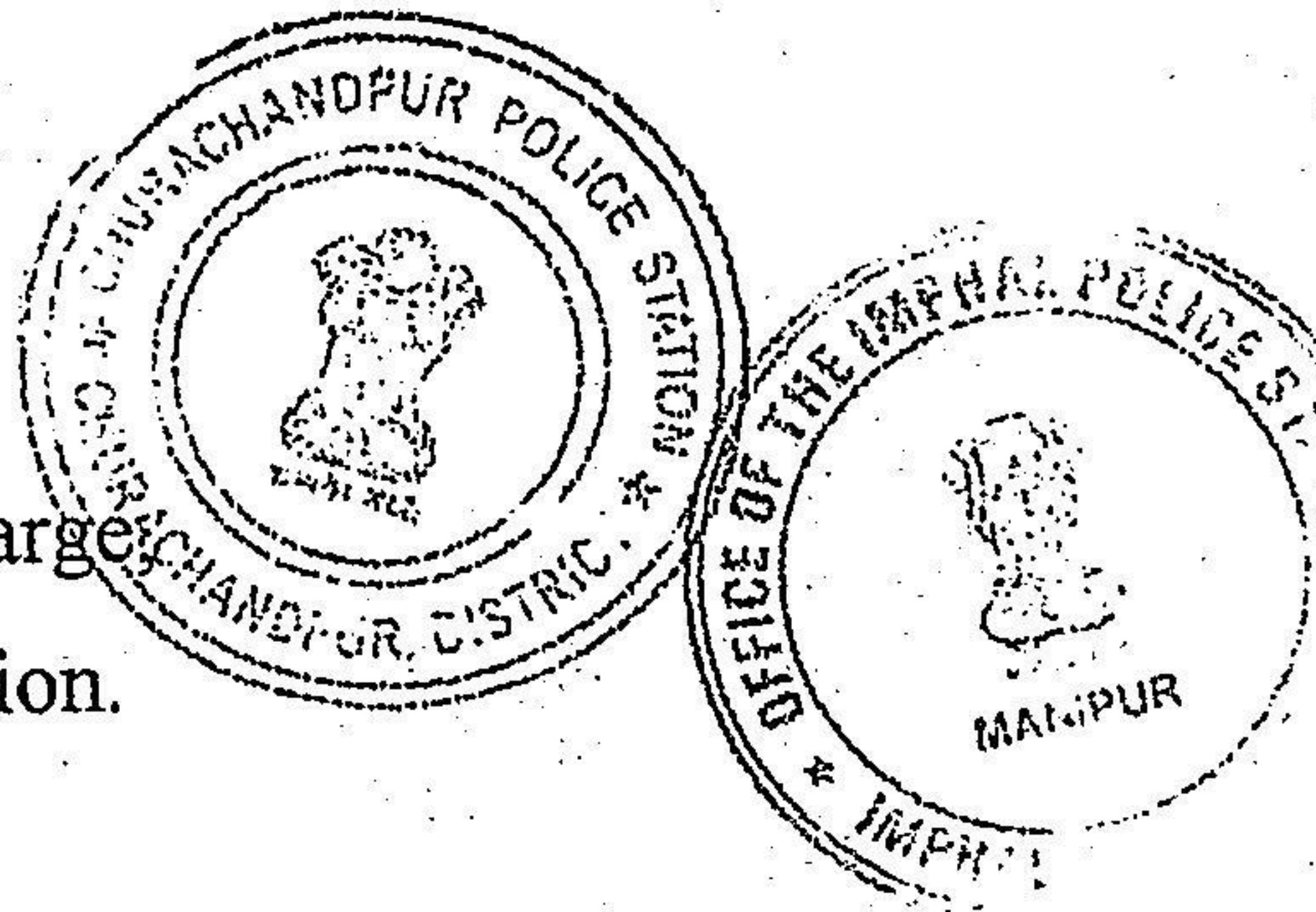

I have the honour to state that on 04/05/2023 at around 11:00 am a group of unknown people numbering about 300/400 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House located at Khumujamba Meitei Leikai, Churachandpur. The total cost of the lost value of my house would be around 35 lakhs approximately. They have looted all my household properties and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM) as per law.
