

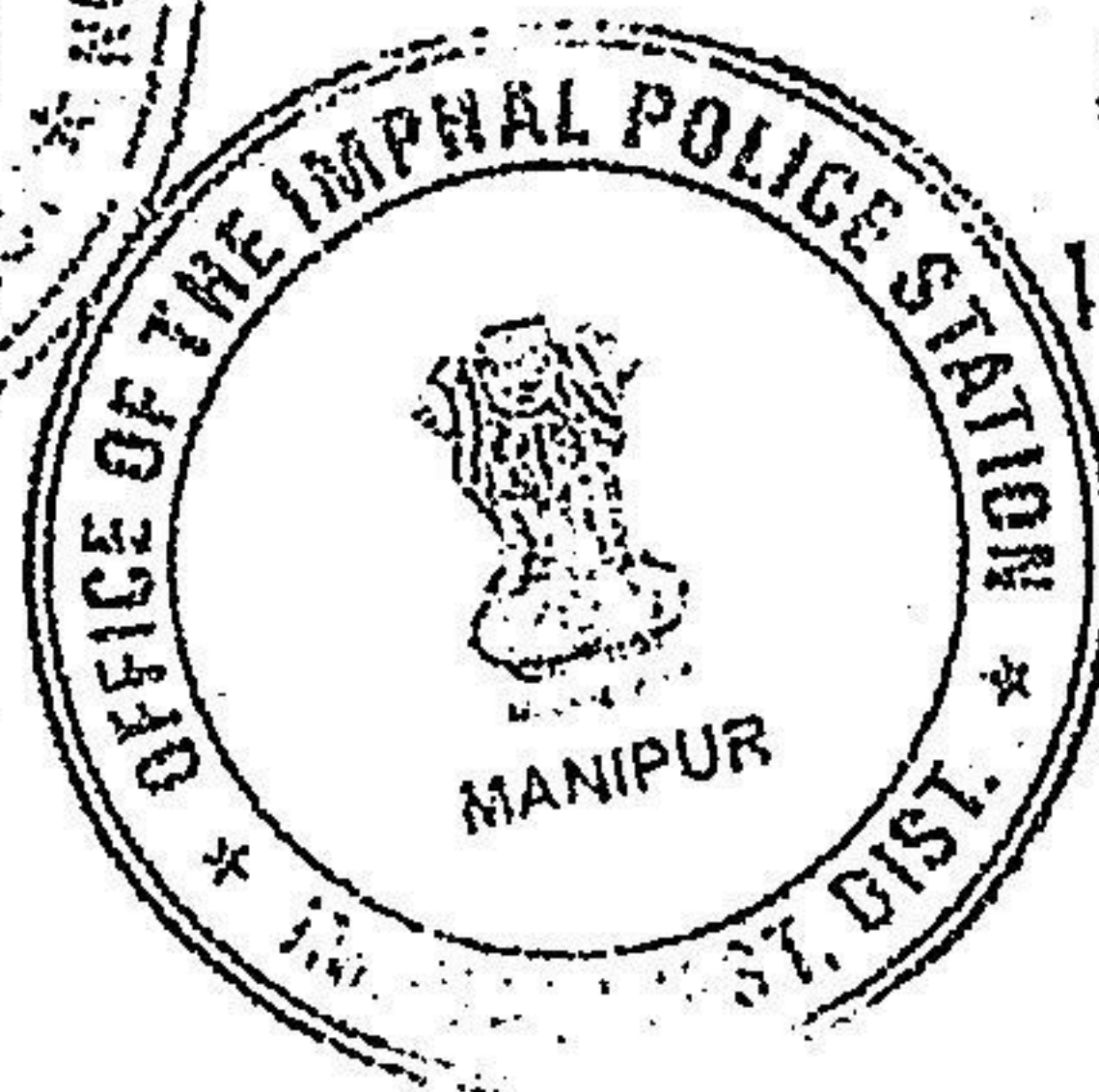

I have the honour to state that on 04/05/2023 at around 11:00 am a group of unknown people numbering about 100/200 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House, my Hostel namely Bright Student Home located at Churachandpur Khumujamba Meitei Leikai, along with my household properties. The total cost of the lost value of the items would be around 15 lakhs approximately. They have looted all the said household properties and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
