

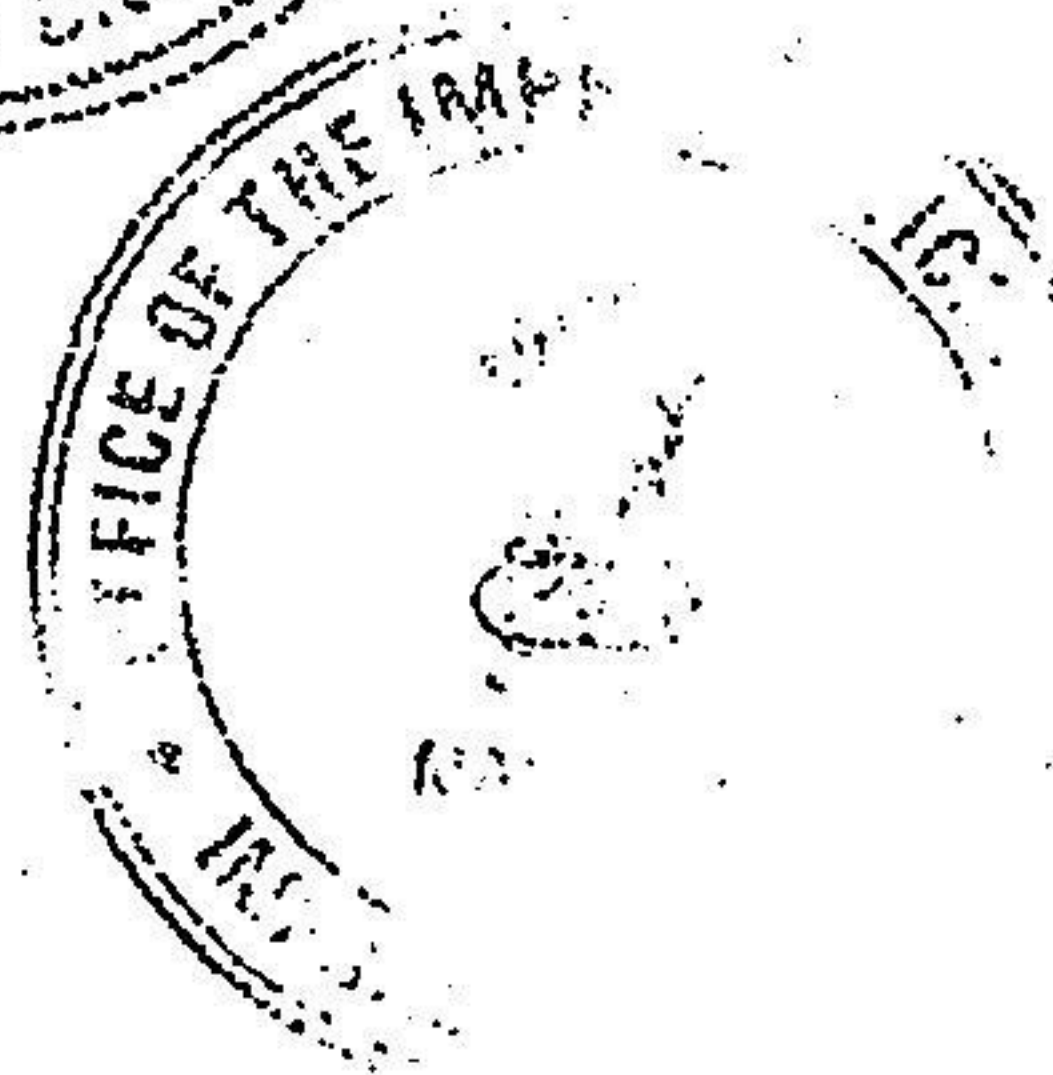
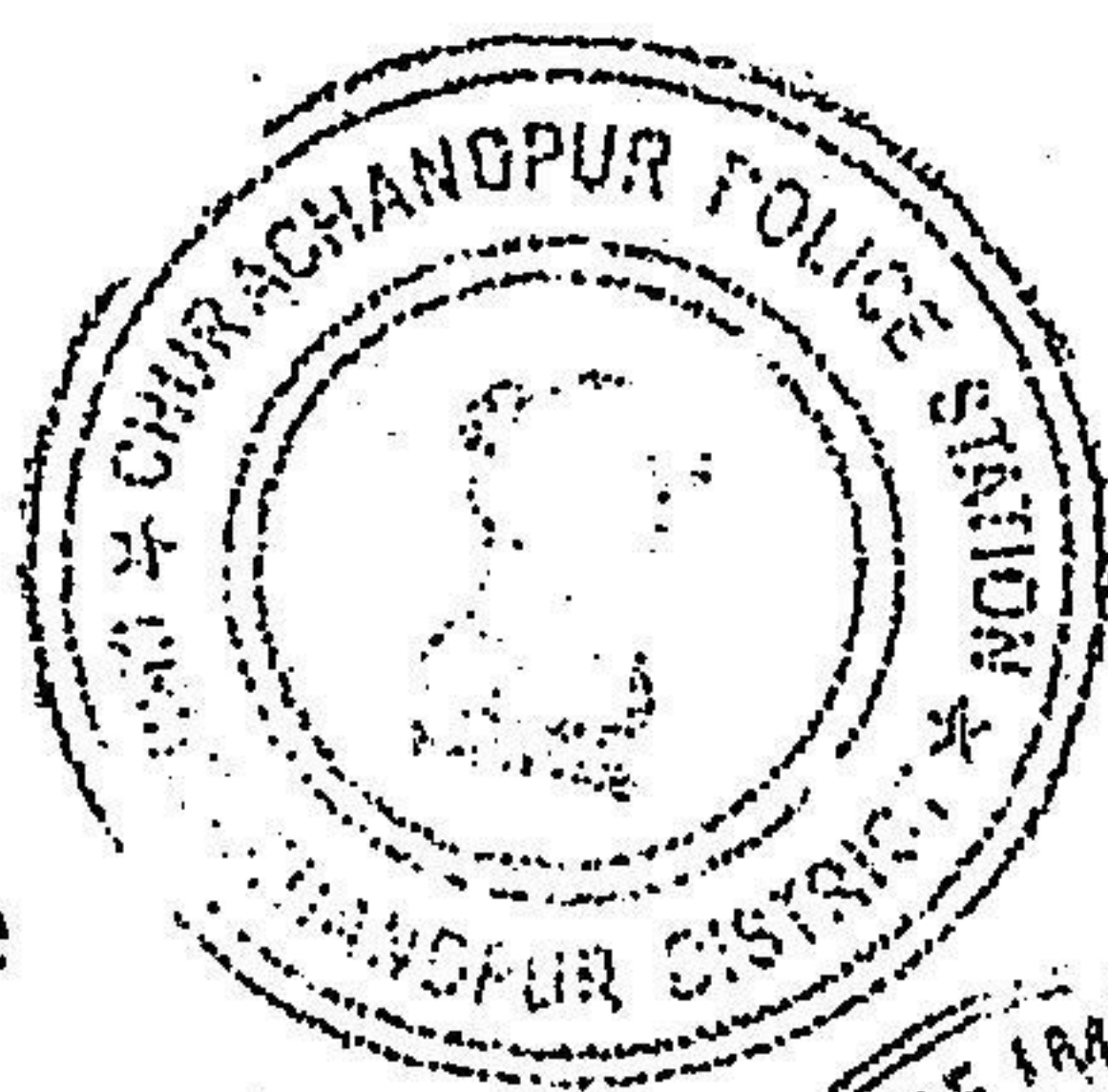

I have the honour to state that on 04/05/2023 at around 09:00 am a group of unknown people numbering about 60/70 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House, located at Churachandpur Khumujamba Meitei Leikai, and one Honda Activa bearing Regn. No. not known, along with some gold ornaments etc. The total cost of the lost value of the above items would be around 1.5 crors approximately. They have looted all the said items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
