I have the honour to state that on 03/05/2023 at around 07:00 pm a group of unknown people numbering about 100/150 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House, located at Churachandpur Khumujamba Meitei Leikai, and two Scooters, one Royal Enfield, one Concrete Machine, one Heavy Crane with Generator 25 KB, .22 Rifle made in Germany registered owner in the name of myself along with cash of Rs, 14 lakhs etc. The total cost of the lost value of the above items would be around 90 lakhs approximately. They have looted all the said items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
