I have the honour to state that on 03/05/2023 at around 08:00 pm a group of unknown people numbering about 100/150 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched our house located at Churachandpur Khumujamba Meitei Leikai and two Scooters. The total cost of the lost value of the above items could be around 40 lakhs. They have looted all my household items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).

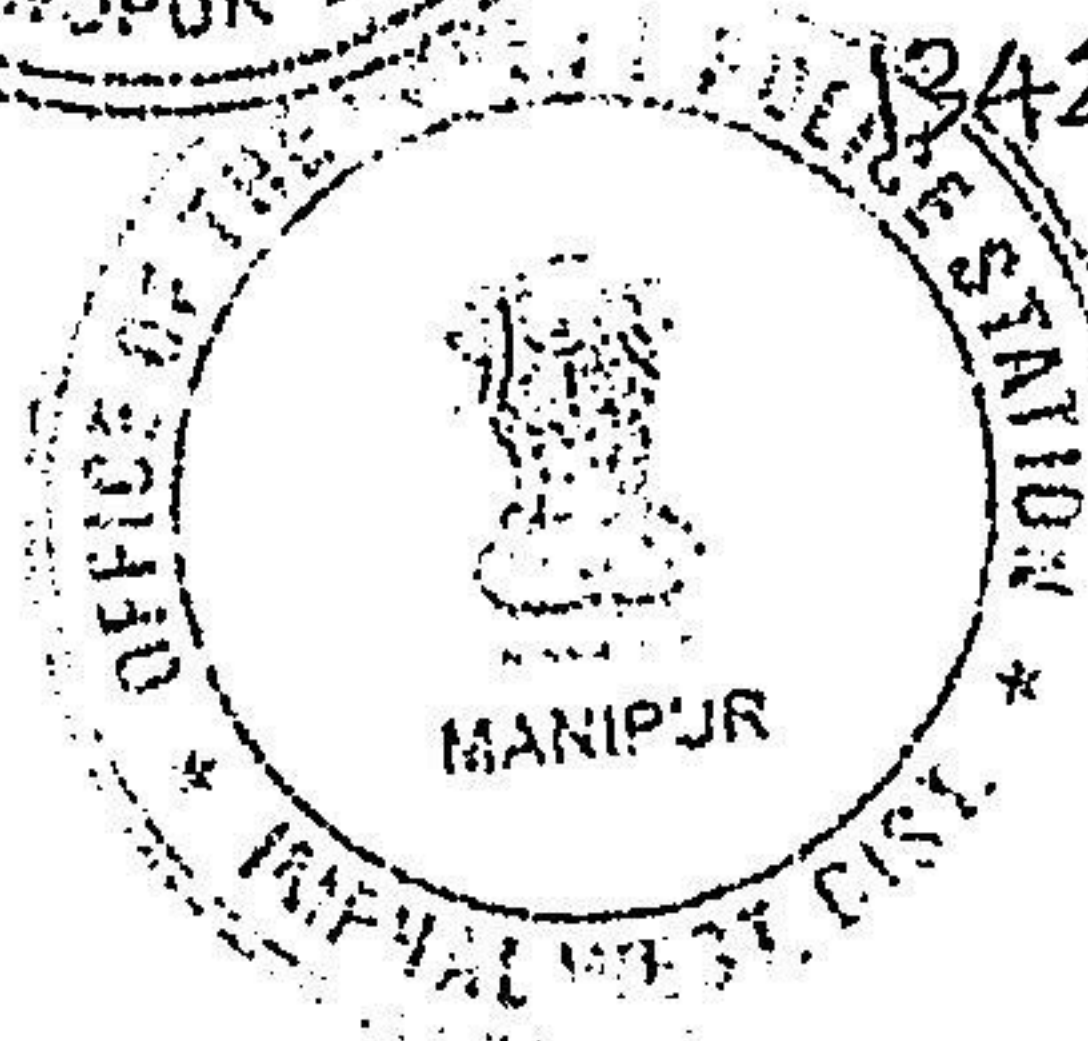
