I have the honour to state that on 03/05/2023 at around 09:00 pm a group of unknown people numbering about 100/150 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House, my Jewellery Shop located at Churachandpur Mandop Leikai along with my two Cars and three Scooters. The total cost of the lost value of the above items would be around 3 crores. In that, the costly jewellery items have been lost. They have looted all my household items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
