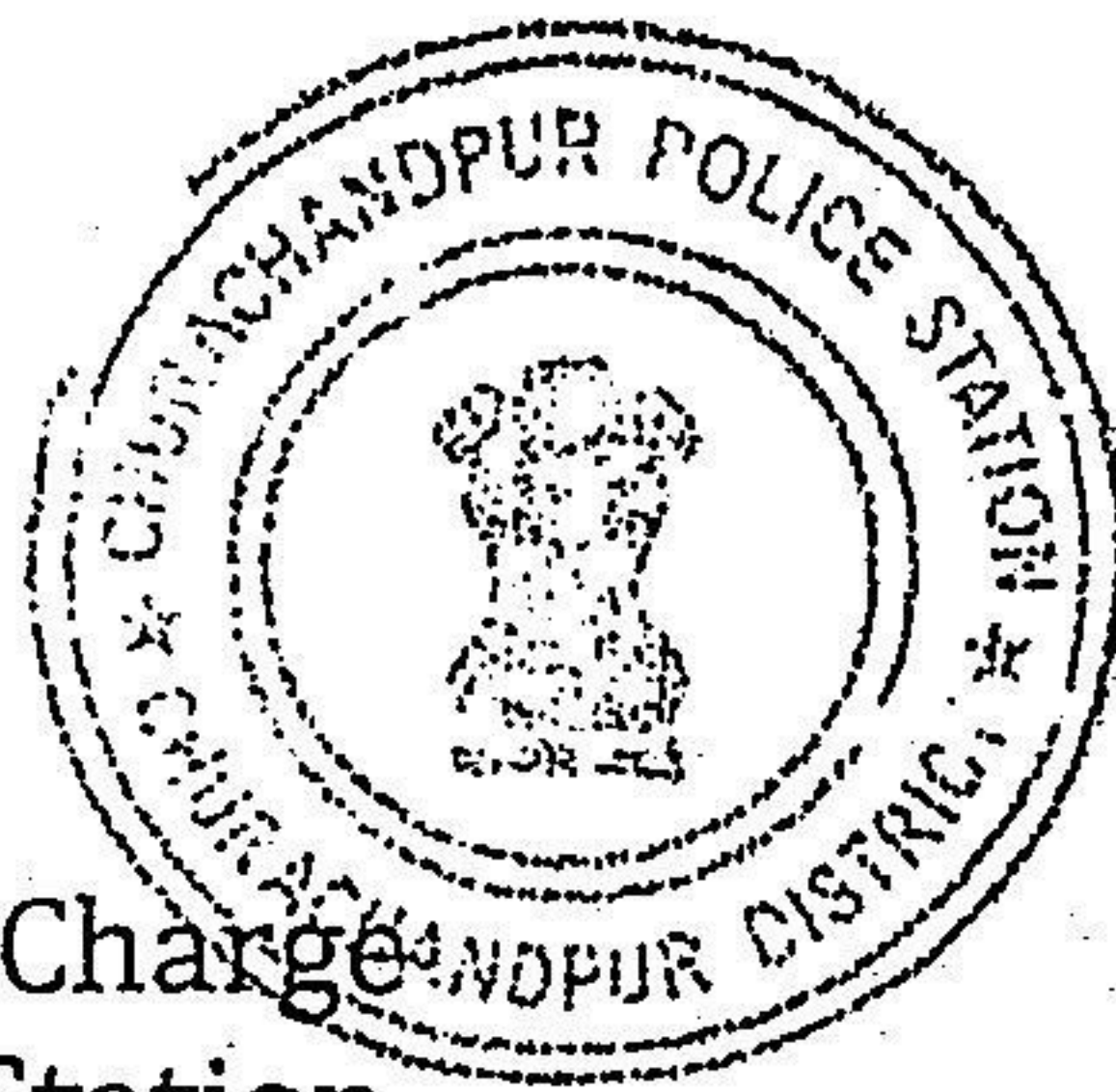

I have the honour to state that on 03/05/2023 at around 11:00 pm a group of unknown people numbering about 500/800 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my 3 nos of House in a different places located at Churachandpur Bijang Khunou Meitei Leikai near Tuiboung Forest Gate and Tuiboung Farm Mamang Meitei Leikai, (Zionveng) respectively. The total cost of the lost value of the buildings would be around 2 crors approximately. They have breaking all the Building and looted household properties and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
