Request for lodging of F.I.R. case regarding looting and ransacking/burnt down of my house located at Churachandpur on 03-05-2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed the Meitei in habitat areas of Churachandpur town on 3rd day of May,2023 at around 707.30 pm. The said unidentified groups vandalized/burnt down my house and properties amounting to a total amount of about Rs. 4000000/-(Forty Lakhs only). After the said unfortunate incident/mob violence my family fled our village in Churachandpur and is now taking shelter at Quarter No-B2, type-II, Commando Complex near JIC office, Imphal West, 795001.

It is, therefore, my prayer that respected sir may kindly initiate and take necessary legal action(s) against the accused persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful to your kind co operation and necessary action(s).
