Subject: Complaint for destruction of my two-wheeler vehicle, TVS Jupiter 125.

Dear Sir,

I, the undersigned have the honour to state that on the fateful night of 3rd May 2023 at somewhere around 7:00 PM, groups of unidentified armed people stormed and attacked Meitei inhabited areas of Churachandpur. The said groups looted all valuable items and demolished and destroyed my house and other belongings including my TVS Jupiter 125 [Registration No. MN 06SG 5147, Chassis No. MD 626 AK 49-N 1H 39152, Engine No. BK 4#N1036303].

I would also like to take up the opportunity to mention that after the said unfortunate incident, my family and I fled from our village, took refuge at Mini Secretariat, Churachandpur for a week till we were evacuated, and are now taking shelter at a relief camp situated at Ideal Women's College, Itkampat, Imphal.

It is, therefore my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused involved in the aforementioned inhumane acts and heinous crimes as per the law of the land.

I shall be forever grateful for your cooperation and necessary actions.
