Subject : Report on losses in the recent communal clash and to take up an FIR.

Sir,

With due respect I, the undersigned, namely Khoisnam Sunjit Singh S/o. Khoisnam Somorjit Singh aged about 37 years a resident of Tuibuang Farm Mamang Meitei Leikai, Churachandpur beg to submit the following few lines for your kind consideration and necessary action.

That, on 3<sup>rd</sup> May, 2023 at about 6:30 p.m. some unknown armed persons numbering about 300 belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelries were burned / destroyed / stolen before burning / damaged including one scooter Activa 6G registered in the name of my wife namely Soram Ronika Chanu bearing a Registration No. MN01 AM 0049 colour blue, engine no. ZF91EW7209105 Chassis No. ME4JF91AFNW209034 were also burned.

We were rescued by Armed Security Personal and provided shelter at a safe place in Churachandpur for the few days.

Later on we have been evacuated to Relief Camp within Bishnupur District under Armed Escort. Hence, I was not able to report regarding this matter to the Police on time. We are still in the Relief Camp at the time of filing this application.

In the above facts and circumstances, it is therefore, respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki Community involved in the burning / dismantling / damaging my properties and request to take up an FIR against them as soon as possible for the interest of justice.
