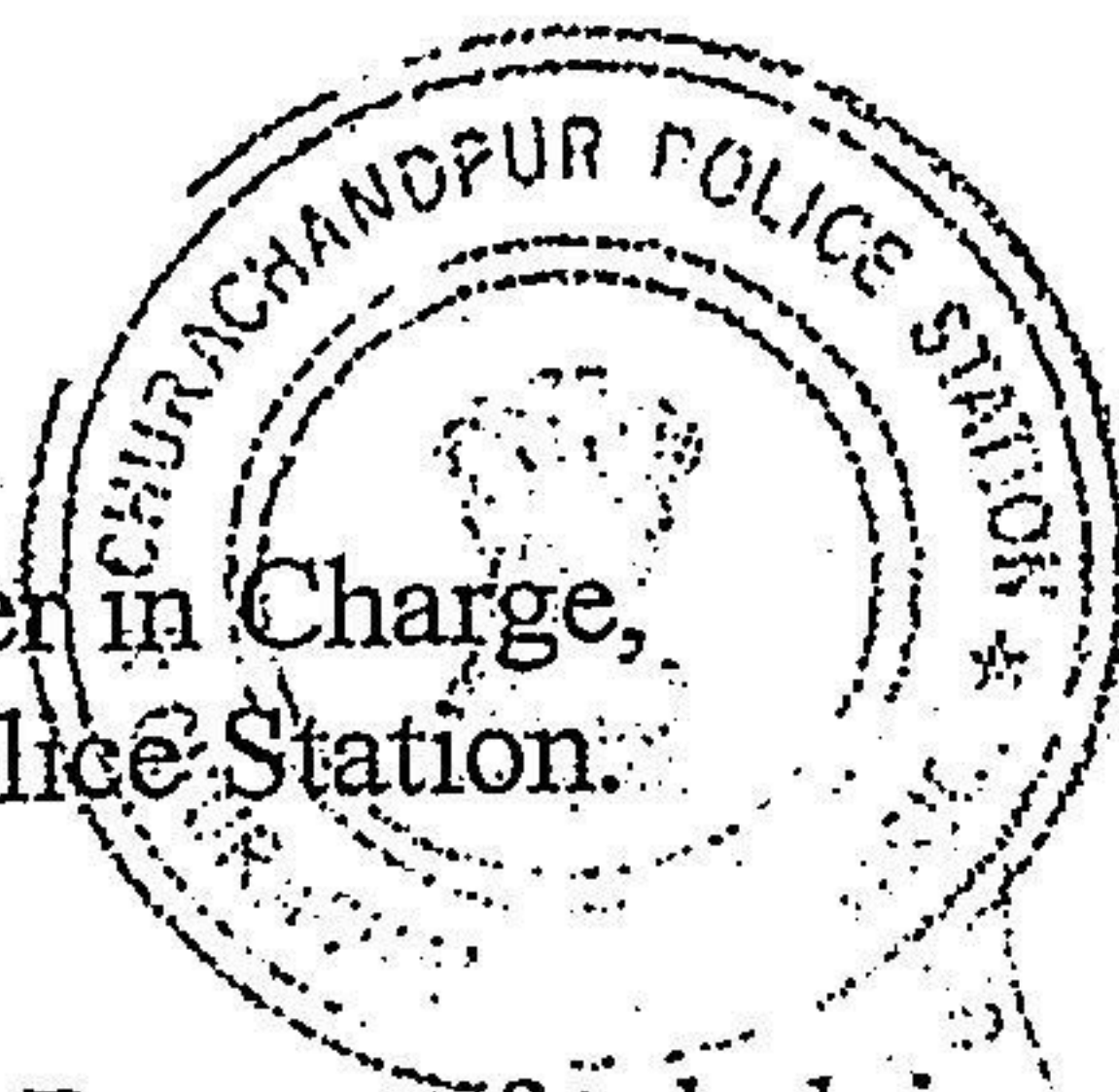

Subject :- Request for lodging of FIR Case regarding looting and ransacking/burnt down of my located at Churachandpur on 03/05/2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant group(s) stormed the Meitei inhabited area(s) of Churachandpur town on 3rd day of May, 2023 at around 5:00 PM. The said unidentified groups vandalised/burnt down my house and looted all valuable items. In that unfortunate incident, I have lost a total amount of about Rs. 60,00,000/- (Rupees Sixty Lakhs) only. After the said unfortunate incident/mob violent, my family fled out village in Churachandpur and is now taking shelter at a relief camp situated at Khuman Lampak, Imphal East District, Manipur.

It is, therefore, my prayer that respected Sir may kindly initiate and take necessary legal action (s) against the accused person and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful for your kind cooperation and necessary action(s).
