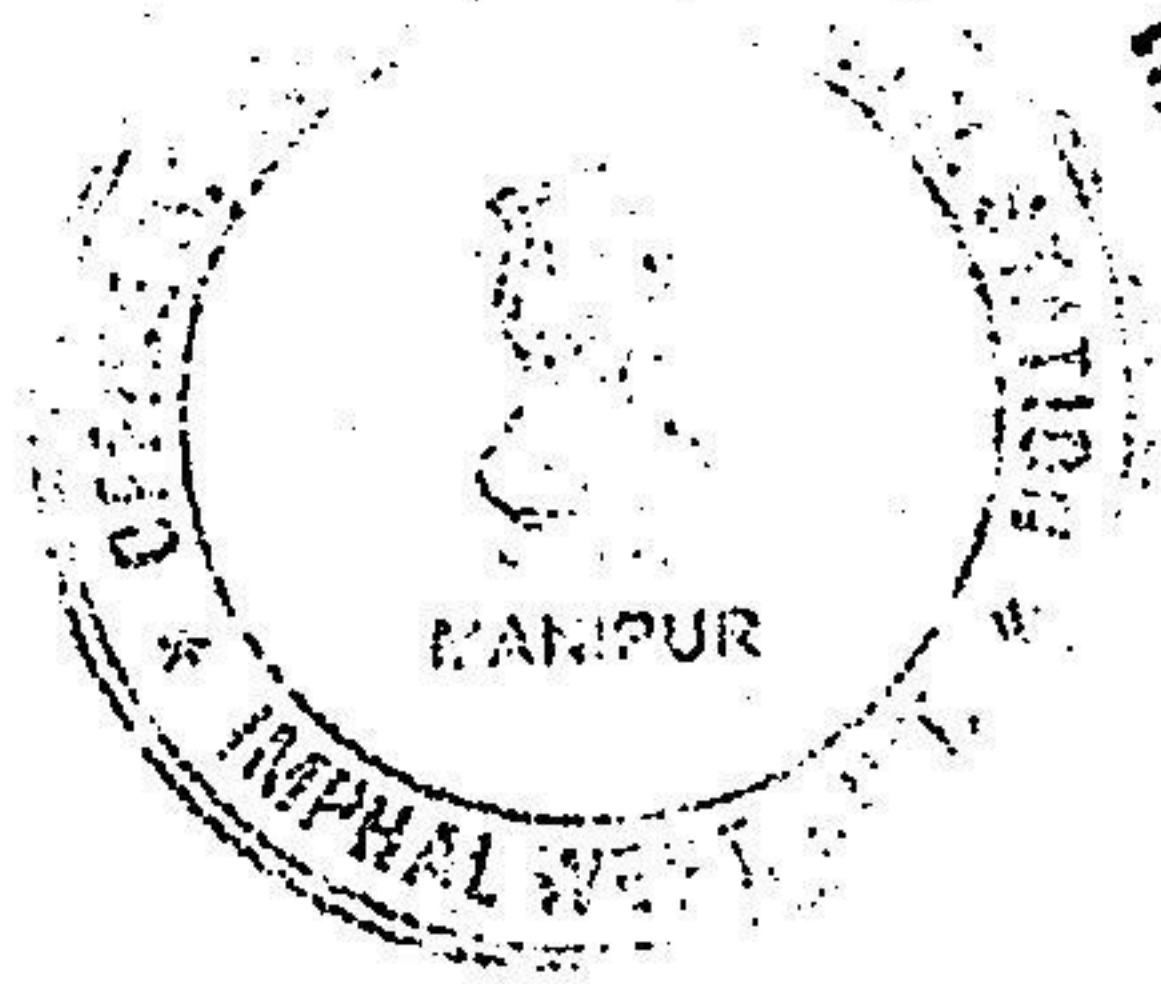

Subject: Request for lodging of F.I.R Case regarding looting my shop located at Churachandpur on 03/05/2023.

Sir,

I, the undersigned have the honor to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militant group(s) stormed the Meitei inhabited area(s) of Mandop Leikai, Churachandpur town on 3rd day of May, 2023 at around 9:00 P.M. The said unidentified groups vandalized my shop M/s JOJO COMMUNICATION (Electronics and electrical CCTV shop) and looted all valuable items. In that unfortunate incident, I have lost a total amount of about Rs. 17 Lakhs.

It is, therefore, my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful for your kind cooperation and necessary action(s).
