Subject: Request for lodging of F.I.R Case regarding looting and ransacking down of my house located at Churachandpur on 03/05/2023.

Sir,

I, the undersigned have the honor to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militant group(s) stormed the Meitei inhabited area(s) of Mandop Leikai, Churachandpur town on 3<sup>rd</sup> day of May, 2023 at around 9:00 P.M. The said unidentified groups vandalized my house and looted all valuable items. In that unfortunate incident, I have lost a total amount of about Rs. 15 Lakhs. After the said unfortunate incident/mob violence, my families have taken shelter at relief camp open at Mini Secretariat up to 9<sup>th</sup> May 2023(1:00pm) and the Govt. of Manipur shifted to relief camp open at khuman lampak main stadium on the same day. Now my family take shelter at my elder brother namely Irengabam Amuba Singh residence situated at Narankonjin Makha Leikai (P.S Wangoi) Imphal West District, Manipur.

It is, therefore, my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful for your kind cooperation and necessary action(s).
