I have the honour to state that on 04/05/2023 at around 10:00 am a group of unknown people numbering about 60/70 suspected to be members of All Tribal Students' Union Manipur (ATSUM) stormed into our locality with arms and other incriminating weapons. They have torched my House and Jewellery Shop located at Churachandpur Khuga Tampak. The total cost of the lost value of the above house and jewellery items would be around 90 lakhs approximately. They have looted household items and valuable articles.

It is therefore, requested kindly to take up necessary legal action against the unknown suspected members of All Tribal Students' Union Manipur (ATSUM).
