Subject: Request for lodging of F.I.R. Case regarding looting and ransacking/burnt down of my house located at Churachandpur on 03/05/2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant group(s) stormed the meitei inhabited area(s) of Churachandpur town on 3rd day of May, 2023 at around 4:30 P.M. The said unidentified groups vandalised/burnt down my house and looted all valuable items. In that unfortunate incident, I have lost our house and property amounting to a total amount of about Rs. 56,00,000 (FIFTY SIX LAKHS ONLY)

After the said unfortunate incident/mob violent, my family fled our village in Churachandpur and is now taking shelter at a relief camp situated at Hostel-2, Khuman Lampak Sports Complex, Imphal East, Manipur.

It is, therefore, my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

I shall forever be grateful for your kind cooperation and necessary action(s).
