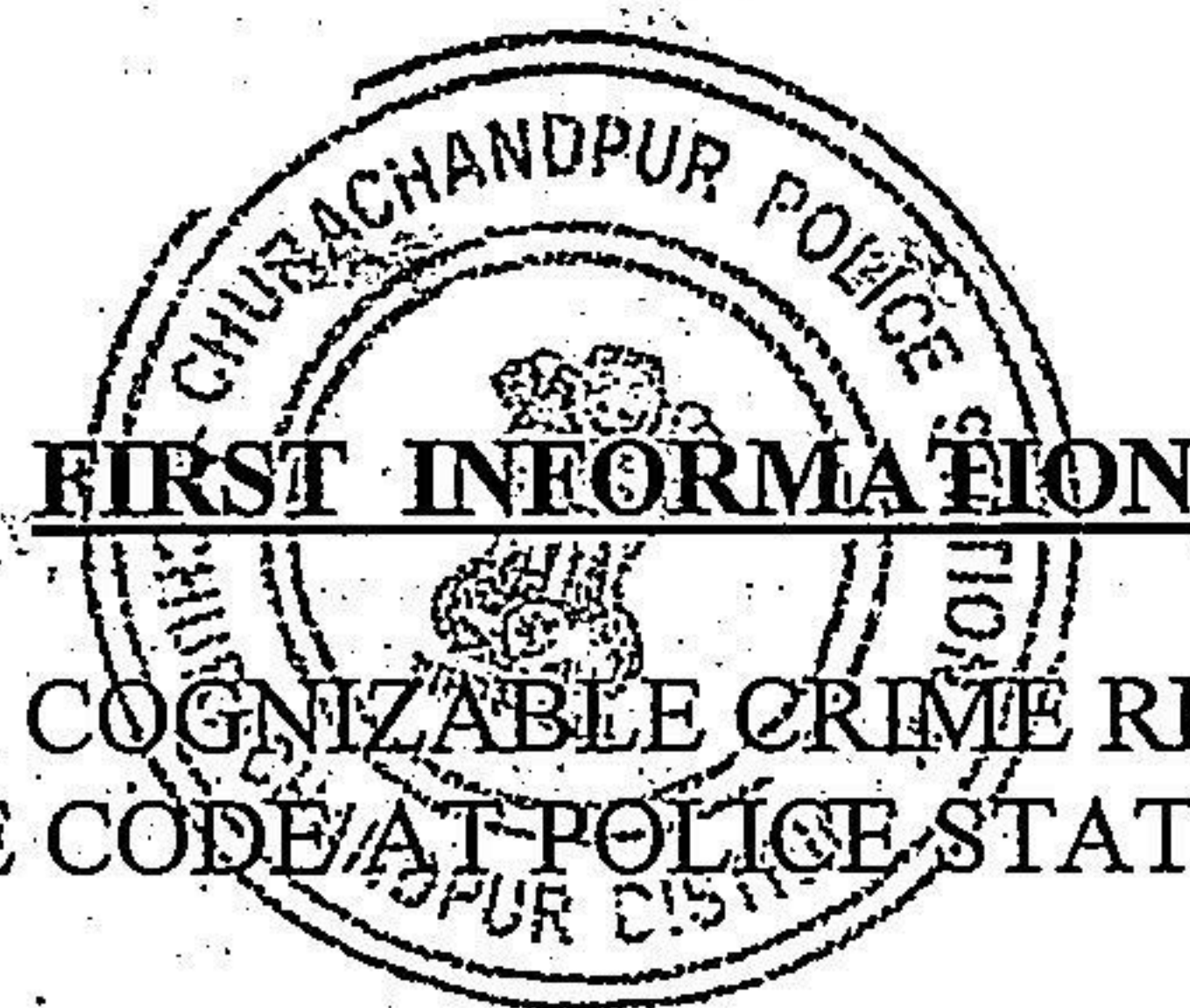

I have the honour to state that on 18/05/2023 at 11.30 am, I was reported by the Choukidar GNMTS, Churachandpur that on the same day i.e. 18/05/2023 at around 11.00 am my Alto K10 VXi, S-Copper in colour bearing Regn. No. MN04P-1412 having Engine No. K10BN4426707 & Chassis No. MA3EADE1S00382275 has been found stolen away by some unknown miscreant(s) while kept parking under lock and key inside the campus of GNMTS, Churachandpur. And the cost of the stolen vehicle is Rs. 2,30,000/- (Rupees two lakh thirty thousand) only. I could not report to the jurisdictional Police Station because of the volatile situation of the communal violence between Meiteis and Kukis.
