I have the honour to report that on 03/05/2023 at @ 4:30 pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militant groups stormed to all Meitei inhabited areas of Churachandpur town. The said unidentified groups vandalized and burnt down rented house and also looted 8 (eight) sons of gold necklace, cash Rs. 37,000/- (rupees thirty seven thousand) only, furniture items and other household articles. Since the day of incident our family members are temporarily staying at a rented house located at Churachandpur Khumujamba Meitei Leikai and also presently taking shelter at the house of my family relative located at Thoubal Leishangthem Khongmanung after the incident. In that unfortunate incident, I have lost a total amount of Rs. 256000/- (two lakhs fifty six thousand) approx.

It is therefore, requested to take necessary legal action against the accused persons and persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law.
