

Subject: Request for lodging FIR case regarding lost of my car and valuable items/cash at Jawahar Navodaya Vidyalaya Churachandpur-reg.

Sir,

I, the undersigned, Akoijam Suranjit Singh, Librarian of Jawahar Navodaya Vidyalaya Churachandpur who is residing at allotted staff quarter of school along with my wife and my little daughter and a permanent resident of Thoubal Melaground, Thoubal, Manipur have the honour to state that on 03/05/2023 at about midnight, we 29 members including my 3 family members were shifted to 36th Assam Rifles Churachandpur by village authority but my car was stranded at car shed nearby my quarter. On 08/05/2023 a group of unknown persons forcefully have taken away my blue coloured Maruti Ignis car bearing Registration Number **MN04P 2519** with all vehicle documents which is inside my car by looting both keys from my quarter. The approximate value of my car is Rupees 07(Seven) lakhs only. Repeatedly, many groups of unknown persons have looted many valuable items/cash from my quarter at JNV Churachandpur which approximately worth Rupees 05(Five) lakhs. On 09/05/2023, we were safely transferred from Churachandpur by army vehicles with tight security escorts and reached home safely. However, mental and physical trauma of myself, my family members is taking long time to recover due to emotional and physical shock that we faced and we are facing.

I, therefore request you to kindly take necessary actions to retrieve my car and valuable items/cash and legal actions against those miscreant persons involved in taking away/using my vehicle, looting my valuable items from my quarter and lodge FIR case as early as possible.

I shall be grateful for your kind co-operation and necessary actions.
