I the undersigned have the honour to state that the following few lines for kind consideration and taking further necessary action.

That, on 23<sup>rd</sup> May, 2023 at around 4:00 pm, received an information through mobile phone that my vehicle JCB 3DX Super 4WD B/Registration No. AR02A3349, Chassis No. HAR3DXSUC0283360 and Engine No. H00232165 yellow colour has been looted and taken by some unknown miscreants suspected to be Kuki militants from Nayang Village, which was kept at the residential campus of village chief of Nayang village (exact name not known), PS – Henglep, Sub-Division – Henglep, Churachandpur District, Manipur. The approximate value of my vehicle JCB 3DX Super is Rs. 26,00,000/- (Twenty Six Lakhs) only.

I could not report the incident to my concerned police station in the time due to the prevailing law and other situation of our state.

I, therefore, request your good office to kindly take up necessary action in this regard.
