I the undersigned have the honour to state that on 04/05/2023 at @ 4:30 pm, a large number of unidentified people belonging to the Kuki Community with deadly weapons storms at our rented house owned by one Lukram Langlen Devi of Zou Veng, Churachandpur and looted all the valuable household items belonging to me. In the unfortunate incident, I have lost a total amount of about Rs. 2,00,000/- (Two Lakh only). I couldn't report of the incident due to the present violence situation of the State.

It is therefore you are requested to take legal action against the persons involved in the incident for the interest of the justice.
