With due respect, I the undersigned namely Angam Sanatomba Singh  
aged about 27 years, resident of Tuibong beg to  
submit the following few lines for your kind consideration and necessary action.

That on 3rd May 2023 at about 9 pm, some unknown persons numbering about  
400/500 belongs to kuki community started attacking the undersigned along with  
family members. Thereafter the kuki people started destroying and burning the house of  
the undersigned were razed to the ground and all the belonging jewelries were also  
burned/destroyed/stolen before burning/damaged.

In the said incident..... was badly injured due to pelting of  
stones /hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particular of all the losses incurred by me is attached  
along with the present application.

In the above fact and circumstances, it is therefore respectfully requested that your good  
self-cause the arrest of the miscreants who belong s to the kuki community involved in the  
burning /dismantling /damaging my properties and injuring .....and  
take up a FIR against them as soon as possible of the interest of justice.

Delay of filling a FIR is due to displacement and uncertainty of relief camp/place.


