On behalf of Khuman pokpa Temple, I the chairman of
Khuman pokpa Temple would like to report that, On
3rd May 2023, Khuman pokpa Temple, located at Tuibong
Bazar, Ceper, was burnt and destroyed by the unknown
agitators, of Kuki community, numbering about 2000 to 3000.
all the property were lost.

List of the property loss are:

- 1) Temple - (45 lakhs)
- 2) Mantop (Hall) - 50 (lakhs)
- 3) Fencing wall - (30 lakhs)
- 4) Temple office - (15 lakhs)
- 5) Temple Gate - (2 lakhs)
- 6) Temple material - (2 lakhs)

Total Rs 144 lakhs.

The temple was there since 1975 (48 yrs). The temple
was totally burnt down by unknown agitators, so, I would
like to request to concern Govt to take necessary action
and please help us for compensation of the said
property loss of the temple.
