Request for taking up legal action for destroying a Hindu Temple. Subject:

Sir,

With due respect, I, the undersigned, aged about 62 years have the honor to state that Radha Krishna Temple ( Praja Mandop ) Mandop Leikai, Churachandpur, belongs to Meetei Hindu community, was desecrated and subsequently destroyed by Kuki people in collusion with armed Kuki milllitants in the communal clash targeting, specifically, minority Meetei people.

UPUR

The heinous crime was committed on the second day of the communal clash, i.e. 4th of May, 2023-at @ 8.00 pm.

In the incident, the temple structure ( Pucca ), Mandop and its adjoining structures which are part of whole complex as well all the belongings of the temple board were reduced to rubbles. The estimated amount of loss is estimated to be about Rs. 60,00,000/-Rupees sixty Lakh).

As our primary concern at that time was to save ourselves, some of us flee to army camps and some were rescued by army and state police. As a consequence I couldn't report this matter to the police on time. I am still at a relief camp (Thangjing Guest House Relief Camp) in Moirang at the time of filing this report.

earnestly request you to take up legal and other necessary actions against those miscreants who caused destruction to our place of worship.
