I, the undersigned beg to report for your kind and necessary action.

1. That, me and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.
2. That, on Wednesday..... Around 6.30..... a.m./p.m., while I was at home along with my family members considering of myself, my husband/wife, children, father, mother and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties.
3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house..... Activa 4G..... Private vehicle important documents, residential Temple/Laishang erected at my pata land and other household items which are given in the list enclosed along with this report. Which worth around Rs..... 10.48 Lakhs/- (Rupees..... Ten Lakhs forty eight thousands.....) approximately.
4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village operantly and that we will face dire consequences if we return to our village again.
I could not report well in time due to the prevailing Law and Order situation and myself and my family members were displaced and stranded, taking refuge in the relief Camp at..... Nachou Jr. High School....., Bishnupur District, Manipur.
In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.


