Subject: A Complaint application for taking
a necessary action for causing damaged and
set on fire of the Ebukhou Pakhangba Temple
Churachandpur, Thingkangphai on 3rd May,
2023.

Sir,

With due regards and humble submission, I the
undersigned on behalf of the Lai committee of Ebukhou
Pakhangba, Thingkangphai, Ce-pur would like to report
that on 3rd May, 2023 at around 7.10 PM an unruly
mob consisting of womenfolk suspected to be tribal community
stormed at Ebukhou Pakhangba Temple located at Thingkangphai
Sabai Leikai and vandalized the properties viz, doors, windows,
Pakhangba Statue, walls, buildings etc. However, no human injury
was found during the incident. The approx. value of the
damaged properties is approx Rs. 25,00,000/- (Rupees twenty five
lacks). Now, I along with my family members were taking
shelter at Relief Camp, SAI Complex, Cotton.

It is, therefore, requested to kindly take up necessary legal
action against the unknown culprits at the earliest.
