Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, on 3rd of May, 2023 at around 4.30 a.m./p.m., some unknown miscreants suspected to be Kuki Militants/Kuki Tribes rushed to our locality with arms/sophisticated weapons and open fired indiscriminately. They have destroyed/burned down the Temple (Laishang) of Lainingthou Sanamahi My Resident which is located at along with Hall and other annexed buildings.
2. That, the properties damaged/destroyed by the miscreants is about Rs. 30000/- (Rupees.....Thirty thousand Only.....) approximately.
3. That, I could not report well in time due to the prevailing law & order situation as well as we were displaced and stranded. I am taking shelter at Thangalawai Sabal Likoi, Relief since 8/05/23 along with my family members till date. Camp

It is therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki Militants and Kuki tribes.
