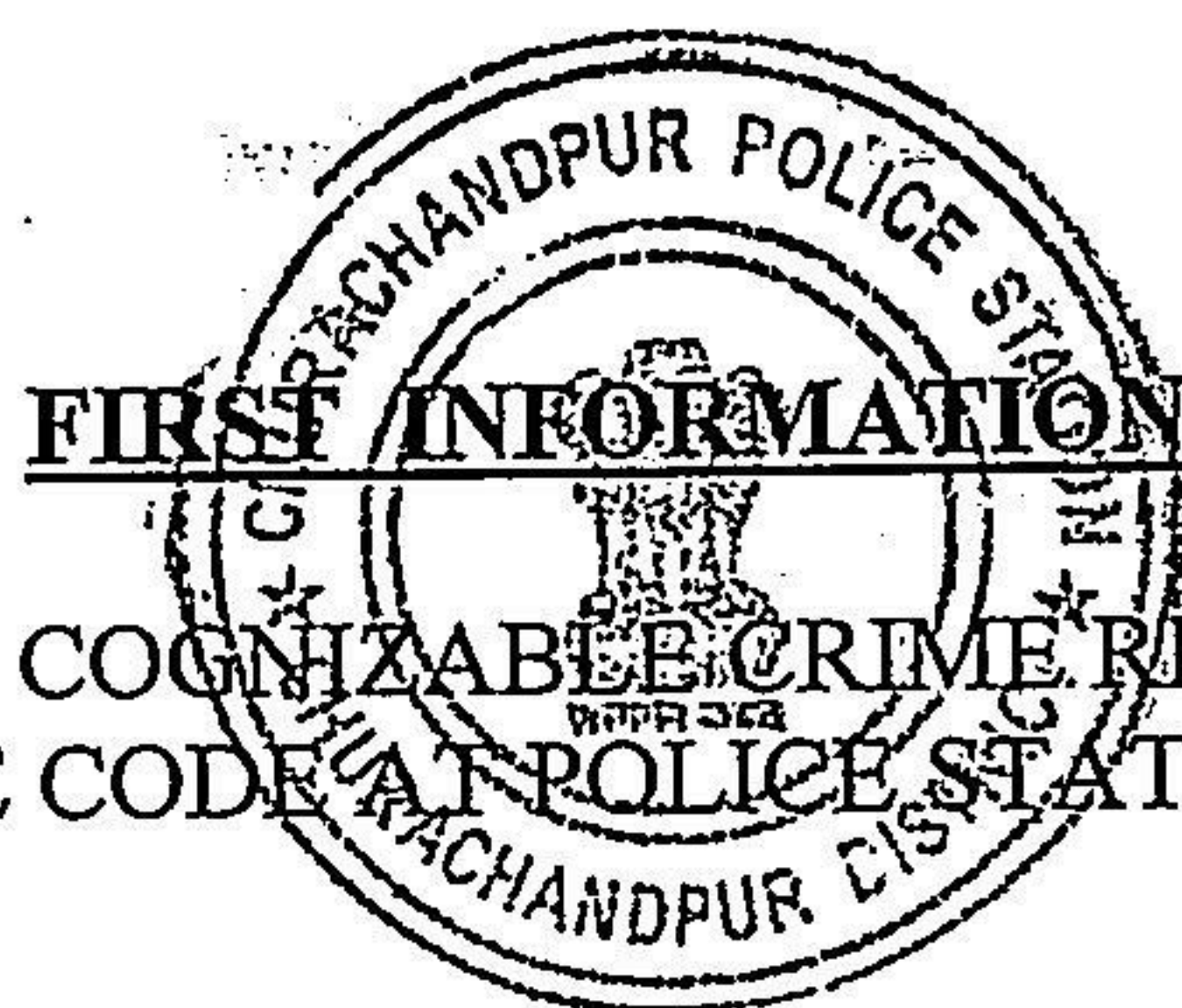

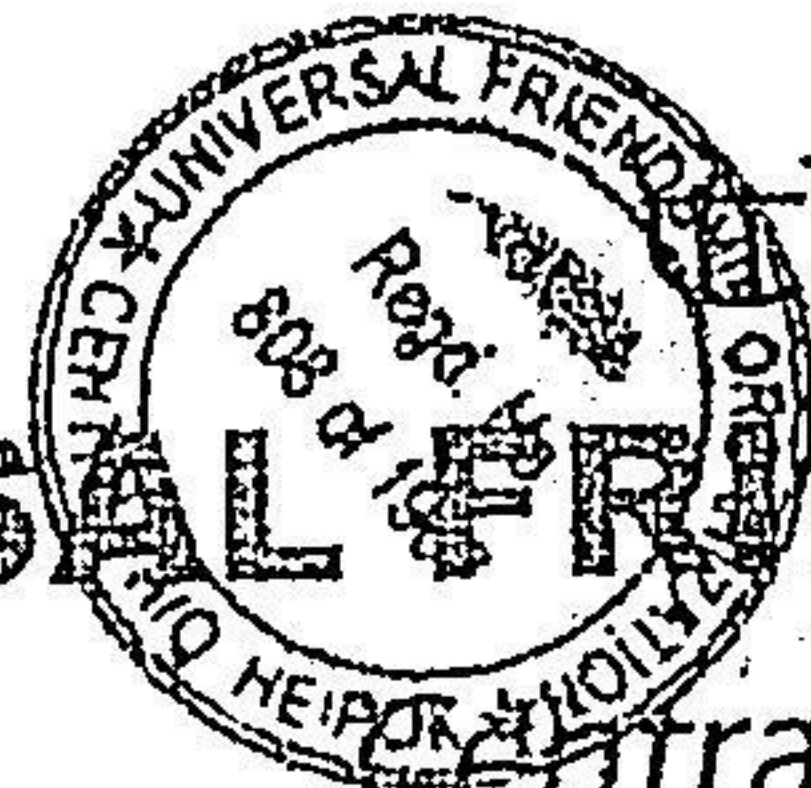

I the undersigned have the honour to report that some armed Kuki militants and others having deadly weapons burnt down the buildings (Sanglen) of the Meitei Huyen Langlon Sindam Sanglen, Satjal Academy, sponsored by the above organisation at Yaiphakol, Meitei Leikai, Churachandpur district on 3rd May at night 7pm. In the burning of losses all the enclosure and building with an estimated value of about Rs 5 lakhs have destroyed.
