Subject:- Request for taking legal action against a mob/gang of Kuki community for burning my house at Churachandpur on 3rd May, 2023.

I have the honour to state that on 3rd May, 2023 at around 4:30 pm a large number of unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabited areas of Churachandpur town.

The said unidentified groups vandalized my house, looted all valuable items and set ablaze. In that incident, I have lost a total amount of Rs 30 lakhs (Approx).

After the said unfortunate incident my family left our village and took shelter at my parental house located at O.B.C girl hostel, Urup, Imphal East District, Manipur.

I was unable to report in time about the incident to the concerned police station as I have been hiding inside the Mini Secretariat, Tuibong, Churachandpur for some days and later we are evacuated to Imphal.

It is, therefore, requested kindly to initiate and taking up necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed as per law as early as possible.

I shall be grateful for your kind co-operation and necessary action(s)
