Sub: Report

Sir,

I have the honour to report that I have been residing at Churachandpur Khuga Tampak more than 20 years on a homestead land having a proper patta land. On 4/5/2023 at around 4:30 a.m. a large number of unidentified groups of people belonging to Kuki Community including Kuki militant groups by holding deadly weapons and by holding sophisticated arms stormed to all Meitei inhabited areas of Churachandpur town.

The said unidentified groups vandalized my house, Grocery Shop and Jewellery Shop located at Rengkai Road near Sugnu Parking and looted all valuable items and set ablaze. In that incident, I have lost a total amount of Rs. 75,000,00/- (Approx).

After the said unfortunate incident my family left our village and took shelter at Relief Camp located at O.B.C girl hostel at Urup, Imphal East District, Manipur.

I was unable to report in time about the incident to the concerned police station as I have been hiding inside the Mini Secretariat, Tuibong, Churachandpur for some days and later we are evacuated to Imphal by the Central force.

It is, therefore, requested kindly to initiate and taking up necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed as per law as early as possible.

I shall be grateful for your kind co-operation and necessary action(s)
