

Subject: Request for loading of FIR Case regarding looting and ransacking my house located at Churachandpur on the 3rd May, 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabited areas of Churachandpur town on the 3rd Day of May, 2023 at around 4:30 pm.

The said in unidentified groups vandalized my house and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 6,00,000/-(Approx.).

After the said unfortunate incident/ mob violent, my family are felling our village and my family is taking shelter at a relief camp (Ideal Girls' College) situated at Akampat, Imphal East District, Manipur.

I was unable to report in time about the incident to the concerned police station as I have been hiding inside the 27th Sector AR, Tuibong, Churachandpur from Kukis Communities regarding the chaos situated in Manipur.

It is, therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused person and persons Remunted as DE OF involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
