Sub: LODGING OF FIR

On 05/08/23 at about 1015 hrs, direction received from Bn HQ 10 Bn BSF to send BP Bunker Casper to provide assistance to F coy 199 Bn BSF deployed at CI POST Phouljang, Dist CC Pur, Manipur. At about 1020 hrs, Sh Gurpreet Singh Asstt Comdr (hereinafter termed as Party Comdr) along with 07 ORs in Casper and Gypsy moved towards CI Post Phouljang F/199 Bn BSF via Kangwai and Village Upa Kailiando Vaiphai. Before move, Party Commander G/10 Bn BSF spoken with Sh Surinder Kelai Asstt.Comdt. F/Coy Comdr 199 Bn BSF to clarify the route as none of the member of G Coy was aware of the route. Sh Surender kela AC informed Party Commander and suggested the route towards Cl post via Kangwai Upa Kailiando Vaiphai. As the party crossed the Thangphai Church, one Kuki OP Post which was established after church on the left side of road, observed the movement of BSF party and immediately informed all miscreants /locals about it. All of a sudden two white gypsy in which 10-12 kuki miscreants/militants who were carrying automatic/ countrymade weapons/ pompy Mortars & Incendiary bombs and tried to overtook BSF vehicles. Although Party Commander directed the gypsy driver not to give pass/side to chasing civil vehicles but those vehicles overtook by dodging BSF vehicle and tried to restrain BSF vehicles. Party Commander directed the party not to stop the vehicles and move continuously. Subsequently TATA Xenon/ Yodha type vehicle, cars and many bikes appeared in front of BSF vehicle which came from left side of the link road before the BSF vehicles reached the Tjunction of village Upa Kailando Vaiphai carrying 30 to 40 kuki miscreants with automatic/countrymade weapons. By the time BSF vehicles reached the T- junction Road, local villagers laid road blocks on the road leading to CI Post Phouljung. Almost 150 to 200 miscreants/militants /locals appeared near village Upa Kailando Vaiphai and blocked the only road leading towards the BSF CI Post Phouljang. The Party Commander directed the vehicle to move towards left side of road leading towards HQ of 09 AR. The QRT/ Sentries of 09 AR HQ which was stationed inside the campus of AR suggested BSF party to park the BSF vehicle inside the campus to avoid any collateral damage as infuriated mob/miscreants/locals were gathering their so rapidly protesting movement of BSF party towards Phouljang. Party commander

mmediately entered the HQ 09 AR campus and parked the vehicle inside the campus. The miscreants were so agitated and were under the impression that BSF party has come to launch operation against them. Party Commander informed all concerned about the incident immediately. Thereafter Party Commander informed the Offg Corndt and Adjt of 09 AR about the incident and who advised BSF party not move the BSF vehicles till the situation normalized.

THE RESERVE OF THE PARTY OF THE

At about 1420 hrs BSF party returned back with AR vehicles which were passing nearly and going towards the BSF G coy 10 Bn, CI post Mayai Leikai (Kangwai Junction) and reached at the coy location back at 1430 hrs, safely.

You are therefore, requested to kindly lodge an FIR against the unknown miscreants /Locals for unauthorizely Obstructing the BSF team to perform bonafide duty and under the other relevant provisions of Act and take necessary action as deemed fit.
