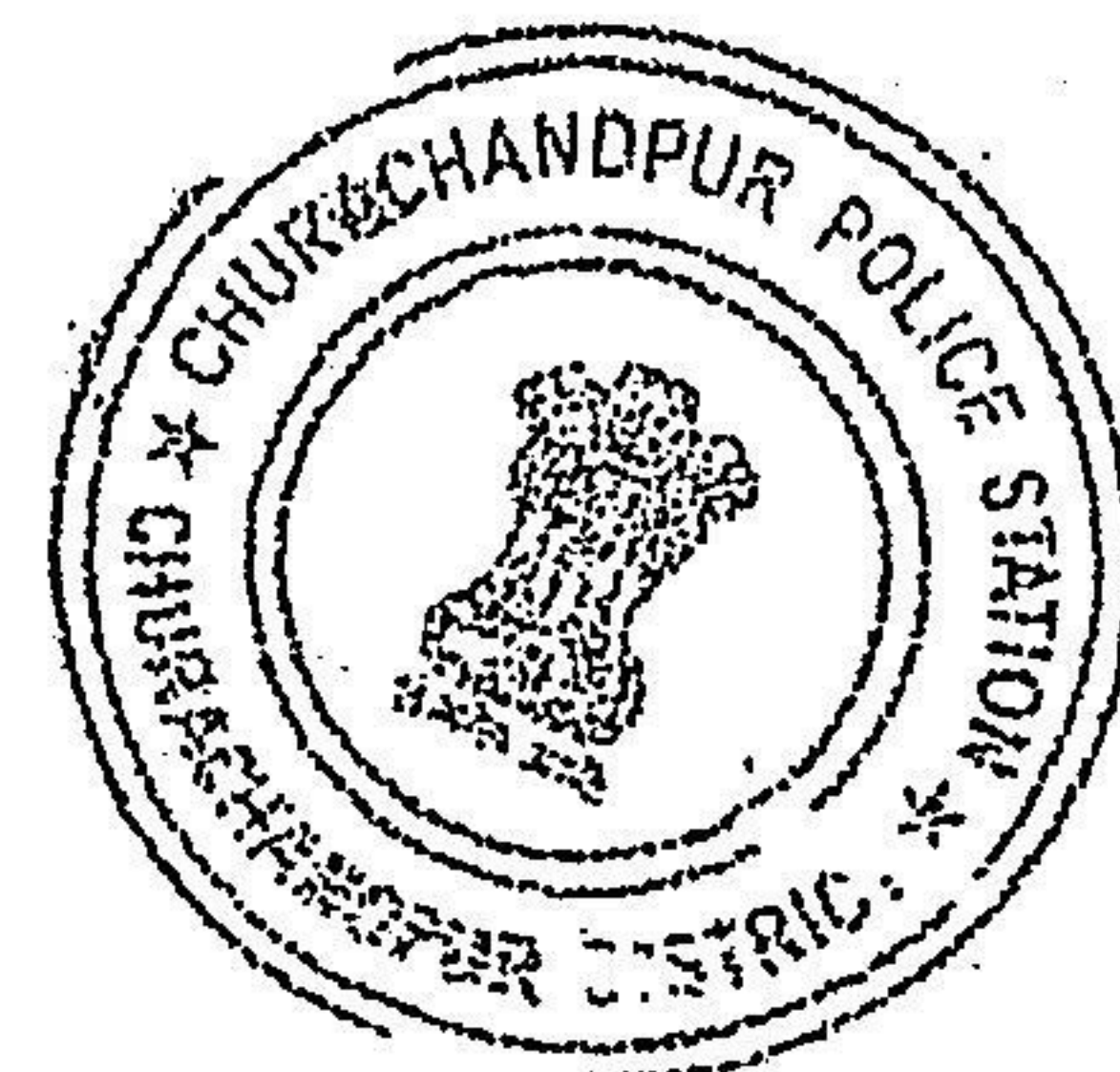

Subject : Report

Sir,

With due respect I, the undersigned namely K. Sudhirchandra, PGT/Phy Posted in JNV Churachandpur, in Tuinom village aged about 50 years, a resident of Lairik Yengbam Awang Leikai, Imphal would like to submit the following few words for your kind consideration and favourable necessary action.

That on 03/05/2023 at about midnight we 29 members including my 5 member family were shifted to 36 Assam Rifles, Ccpur by Village Authority and our Vehicles Key were handed to one of the teacher who is station there in the campus. On 08/05/2023 some unknown youths numbering about 25 to 30 have taken my Silver coloured Wagon R Vxi car bearing Registration no. MN 05A 9765. We were transferred safely from Ccpur on 09/05/2023 by Army vehicles with tight security escorts but on 10/05/2023 at about 10:20 pm Vice Principal, Anjani Kumar rang up me and informed me that the lock of my JNV Churachandpur quarter was broken my beds and clothes were found scattered. I have apprehension of loss of my belongings from my allotted staff quarter.

Again, on 13/05/2023 at about 5:10 pm, Vice Principal informed me through phone that some unknown youths of about 30 in numbers have taken away my White coloured Ciaz Vxi+ bearing Registration no. MN 06L 8046 by breaking the lock of my garage and my red coloured Activa 3G bearing Registration no. MN 01AB 8037 taking key from my quarter.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants involved in using/ taking away my Vehicles and take an FIR against them as soon as possible for the interest of justice.
