Sir,

I would like to file a complaint against unknown miscreants of Churachandpur for damaging my Furniture Showroom brand name HATIL situated at 1st Floor Sharon Tower in New Bazar, Thangjam Road, Churachandpur. The property is under the premises of the current MLA of Churachandpur Mr. LM Khaute.

The showroom had remained closed due to the ongoing communal tension since 3rd May 2023. However, it has been reported that some miscreants numbering about 1000/1500 had forcibly entered the said showroom on the night of 16th May, 2023 at around 11.30 pm. They have destroyed and looted the showroom. Due to the current situation we are not able to determine the damage we have suffered. Once Internet Service resumes I will check our database and submit the details of the damage we have suffered.

I request you to kindly register an FIR against those culprits under the relevant section of the law.
