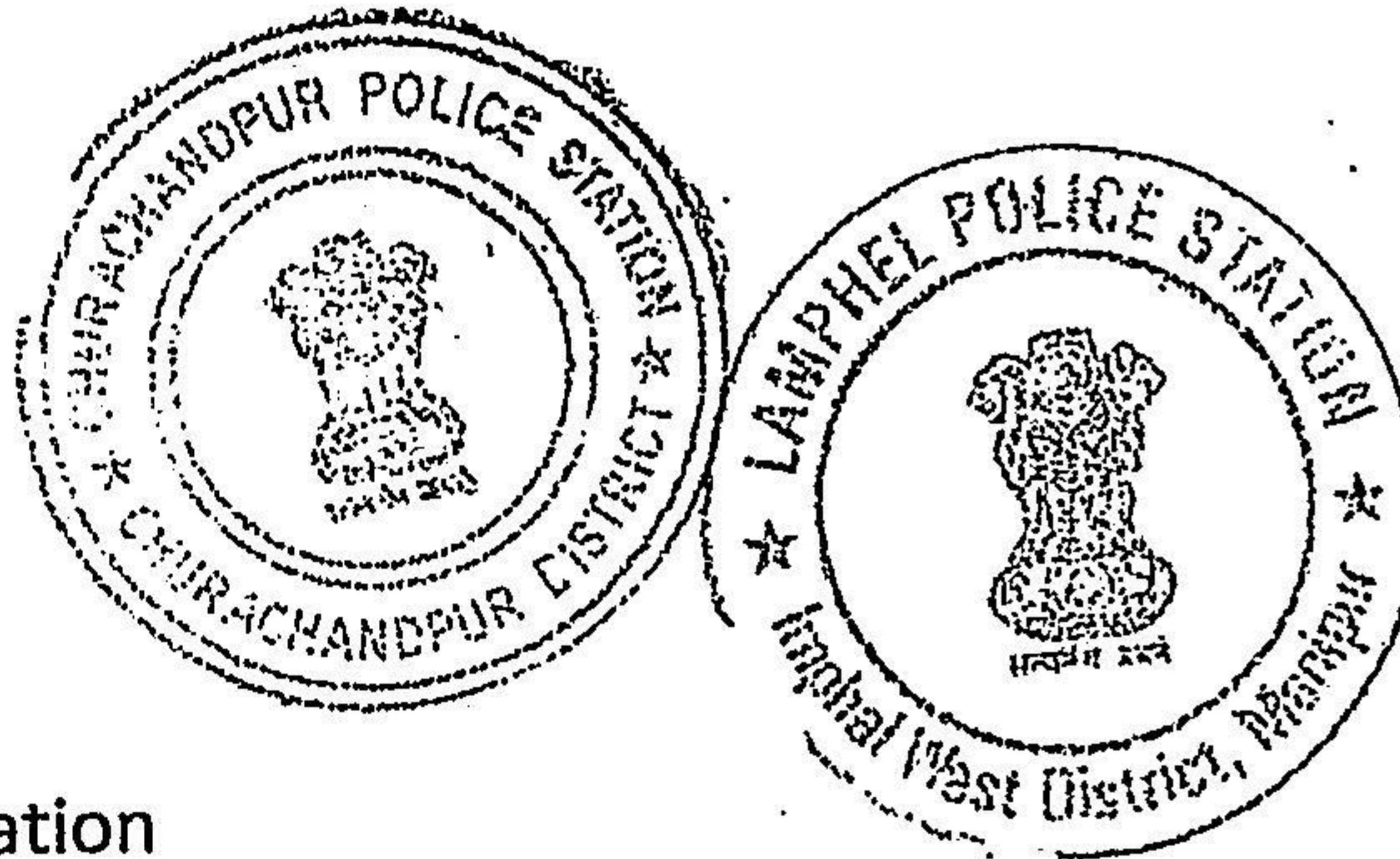

I bring it to your kind attention that the slogan "Biren Shakthu" which was cried and shouted by the participators of an unfortunate demeaning violent rally at Churchandpur district that was organised and incited by ATSUM (All Tribals Student Union Manipur) on 3<sup>rd</sup> May 2023. Such slogans have defamed, insulted and harmed the image of the Hon'ble Chief Minister of Manipur and State Govt of Manipur at large.

It should also be noted that the slogan "Biren Shakthu" was used in separate events on 27<sup>th</sup> April, 2023 and 28<sup>th</sup> April, 2023 where an open gym, Forest Office at Tuibong Gate and many other public properties were burnt down and destroyed.

As such, in the interest of Public order and all the law abiding citizens of the Country, I request you to file an FIR and book the culprits under related sections of law.
